An Act to amend the Libraries and Institutes Act, 1939-1964.

[Assented to 6th April, 1967.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

- 1. (1) This Act may be cited as the "Libraries and Institutes Act Amendment Act, 1967".
- (2) The Libraries and Institutes Act, 1939-1964, as amended by this Act, may be cited as the "Libraries and Institutes Act, 1939-1967".
- (3) The Libraries and Institutes Act, 1939-1964, is hereinafter referred to as "the principal Act".

Incorporation.

2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act.

Amendment of long title of principal Act.

3. The long title of the principal Act is amended by striking out therefrom the passage "public library" and inserting in lieu thereof the passage "State Library".

Amendment of principal Act, s. 18— Officers.

4. Subsection (1) of section 18 of the principal Act is amended by inserting after the passage "principal librarian," the passage "(who, after the commencement of the Libraries and Institutes Act Amendment Act, 1967, shall be known as the 'State Librarian'),".

5. Subsection (2) of section 19 of the principal Act is amended by striking out therefrom the passage "principal librarian" and inserting in lieu thereof the passage "State Librarian".

Amendment of principal Act, s. 19— Department of the public service.

6. The following section is enacted and inserted in the Bnactment of s. 19a of principal Act after section 19 thereof: principal Act after section 19 thereof:-

19a. On and after the commencement of the Libraries State Library of South Australia. and Institutes Act Amendment Act, 1967—

- (a) the library known as the Public Library or the Public Library of South Australia shall be known as the State Library of South Australia; and
- (b) any reference in any other Act, Regulation, Proclamation or document to the public library or to the principal librarian, shall be read and construed as a reference to the State Library of South Australia and to the State Librarian respectively unless the context otherwise requires.
- 7. Section 20 of the principal Act is amended by striking out principal Act, erefrom the passage "public library" wherever occurring s. 20 therefrom the passage "public library" wherever occurring therein and inserting in lieu thereof, in each case, the passage "State Library".

General powers and duties of the board.

8. Subsection (1) of section 22 of the principal Act is amended principal Act, striking out therefrom the passage "public library" and s. 22 by striking out therefrom the passage "public library" and inserting in lieu thereof the passage "State Library".

Disposal of moneys voted.

9. Section 23 of the principal Act is amended by striking Amendment of principal Act, at therefrom the passage "public library" twice occurring 8. 23 out therefrom the passage "public library" twice occurring therein and inserting in lieu thereof, in each case, the passage retain property in the board.

10. Section 149 of the principal Act is amended by striking out therefrom the passage "public library" wherever occurring 149. therein and inserting in lieu thereof, in each case, the passage Regulations. "State Library".

11. Subsection (3) of section 156 of the principal Act is amended by striking out therefrom the passage "public library" s. 156—

Transfer of and inserting in lieu thereof the passage "State Library".
