An Act to amend the Local Government Act, 1934, as amended, and certain other Acts relating to local government.

[Assented to 23rd November, 1972]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

1. (1) This Act may be cited as the "Local Government Act Amendment Act (No. 2), 1972". Short titles.

(2) The Local Government Act, 1934-1972, as amended by this Act and by all Acts amending the same prior to the commencement of this Act, may be cited as the "Local Government Act, 1934-1972".

(3) The Local Government Act, 1934-1972, is hereinafter referred to as "the principal Act".

2. (1) The various provisions of the principal Act set out in the first column of the first schedule to this Act are amended in the manner indicated in that schedule. Amendment of principal Act.

(2) Section 895 of the principal Act is repealed.

(3) The tenth schedule to the principal Act is repealed and the following schedule is enacted and inserted in its place:—
