An Act to amend the Local Government Finance Authority Act 1983.

[Assented to 3 September 1998]

The Parliament of South Australia enacts as follows:

Short title

- 1. (1) This Act may be cited as the Local Government Finance Authority (Board Membership) Amendment Act 1998.
- (2) The Local Government Finance Authority Act 1983 is referred to in this Act as "the principal Act".

Amendment of s. 7—Constitution of the Board

- 2. Section 7 of the principal Act is amended—
- (a) by striking out from subsection (1) "The Board" and substituting "Subject to this section, the Board";
- (b) by inserting after subsection (3) the following subsection:
 - (3a) The Board may co-opt as an additional member or as additional members of the Board one or two persons with financial expertise to assist the Board in the performance of its functions.

Amendment of s. 8—Terms and conditions of office

- 3. Section 8 of the principal Act is amended by inserting after subsection (7) the following subsection:
 - (8) The following provisions apply with respect to the appointment of a co-opted member of the Board:
 - (a) an appointment will be made on conditions determined by the Board and may be limited in accordance with the terms of the instrument of appointment; and

(b) an appointment may be terminated at any time by resolution of the Board or the Authority.

Amendment of s. 10-Procedures, etc., of the Board

- 4. Section 10 of the principal Act is amended by striking out subsection (1) and substituting the following subsection:
 - (1) A quorum at a meeting of the Board consists of one-half of the total number of its members (ignoring any fraction resulting from the division) plus one.

Amendment of s. 13-Allowances and expenses for members

- 5. Section 13 of the principal Act is amended by inserting after subsection (2) the following subsection:
 - (3) The Board may determine to pay to co-opted members of the Board amounts that are additional to the allowances payable under subsection (1).

Amendment of s. 34—Annual report

6. Section 34 of the principal Act is amended by inserting in subsection (3) "within 12 sitting days after his or her receipt of the report" after "Parliament".

7. The principal Act is further amended in the manner indicated in the schedule.
