An Act to amend the Mental Health Act, 1935-1965.

[Assented to 24th November, 1966.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. (1) This Act may be cited as the "Mental Health Act short utles. Amendment Act, 1966".
- (2) The Mental Health Act, 1935-1965, as amended by this Act, may be cited as the "Mental Health Act, 1935-1966".
- (3) The Mental Health Act, 1935-1965, is hereinafter referred to as "the principal Act".
- 2. This Act is incorporated with the principal Act and that Incorporation. Act and this Act shall be read as one Act.
- 3. Subsection (1) of section 4 of the principal Act is amended by striking out the definition of "Director-General" therein and --inserting in lieu thereof the following definition:—

- "Director" means the Director of Mental Health Services appointed pursuant to section 5 of this Act:.
- 4. Section 5 of the principal Act is repealed and re-enacted Repeal and re-enacted re-enactment as follows:-

5. (1) There shall be a Director of Mental Health Services Director of Mental Health who shall be appointed pursuant and subject to the Public Services. Service Act, 1936-1965.

(2) The person who immediately before the commencement of the Mental Health Act Amendment Act, 1966, was holding office as the Director of Mental Health pursuant to section 11a of this Act as then in force shall continue to hold office as the Director of Mental Health Services as if appointed under this section.

Repeal of s. 6 of principal Act— Tenure of office.

5. Section 6 of the principal Act is repealed.

Amendment of

- principal Act, Deputy Director.
- 6. Section 7 of the principal Act is amended—
 - (a) by striking out the word "Director-General" (wherever occurring) therein and inserting in lieu thereof in each case the word "Director";

and

(b) by striking out the words "Medical Services" therein and inserting in lieu thereof the words "Mental Health Services".

Repeal of s. 11a of principal Director of Mental Health.

7. Section 11a of the principal Act is repealed.

Amendment of principal Act, s. 37b— Admission of intellectually retarded persons to training centre.

8. Subsection (1) of section 37b of the principal Act is amended by striking out the word "less" in paragraph (b) thereof and inserting in lieu thereof the word "more".

Repeal of s. 165 of principal Act.

9. Section 165 of the principal Act is repealed.

General amendments
of principal Act
relating to
the DirectorGeneral of
Medical Services

10. The principal Act is amended by striking out the words "Director-General of Medical Services" and "Director-General" (wherever occurring) therein (except in any section referred to in the preceding provisions of this Act) and inserting in lieu thereof in each case the word "Director".
