An Act to amend the Metropolitan Milk Supply Act, 1946.

[Assented to 4 December 1986]

The Parliament of South Australia enacts as follows:

Short title.

1. (1) This Act may be cited as the "Metropolitan Milk Supply Act Amendment Act, 1986".

(2) The Metropolitan Milk Supply Act, 1946, is in this Act referred to as "the principal Act".

Commencement.

Amendment of s. 3-

Interpretation.

2. This Act shall come into operation on a day to be fixed by proclamation.

3. Section 3 of the principal Act is amended by inserting in subsection (1) after the definition of "dairy farm" the following definition:

"Dairy Industry Advisory Committee" means the Dairy Industry Advisory Committee established under the Dairy Industry Act, 1928:.

4. Section 29 of the principal Act is amended by inserting after subsection (2) the following subsection:

(2a) The board may, on the application of the holder of a milk producer's licence, amend the licence by deleting the reference to the premises specified in the licence and substituting a reference to premises specified by the milk producer in the application.

5. Section 32 of the principal Act is amended by inserting after subsection (3) the following subsections:

(3a) Where the Minister, after consulting with the Dairy Industry Advisory Committee, is of the opinion that the issue of further milk producer's licences would result in lower returns to licensed milk producers thus rendering milk production uneconomic, the Minister may direct that no further licences be issued to milk producers.

(3b) A direction under subsection (3a) shall not affect an application for renewal of a current licence.

Amendment of s. 29— Milk producer's licences.

Amendment of s. 32— Refusal of licences. (3c) The Minister may, after consulting with the Dairy Industry Advisory Committee, revoke a direction under subsection (3a).

(3d) The board shall comply with a direction of the Minister under subsection (3a).

(3e) No direction shall be made under subsection (3a) on or after 30 June, 1988, and all directions made under that subsection shall expire on that date.

6. Section 44 of the principal Act is amended by striking out from Amendment of subsection (3) the passage "two hundred dollars" and substituting "\$2 500". Right of holds

7. Section 46 of the principal Act is amended by striking out from $A_{\text{mendment of}}$ paragraph (k) the passage "one hundred dollars" and substituting "\$1 000".

8. Section 49 of the principal Act is amended by striking out the passage "two hundred dollars" and substituting "\$2 500".
