An Act to amend the Motor Vehicles Act, 1959-1974.

[Assented to 27th March, 1975]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

1. (1) This Act may be cited as the "Motor Vehicles Act Amendment Act, 1975".

(2) The Motor Vehicles Act, 1959-1974, is hereinafter referred to as "the principal Act".

(3) The principal Act, as amended by this Act may be cited as the "Motor Vehicles Act, 1959-1975".

Commence-
ment.

2. This Act shall come into operation on a day to be fixed by proclamation.

3. The third schedule to the principal Act is amended—

(a) by striking out the item—

Section 67 (2) Passing stop line or entering pedestrian
crossing while "stop" sign is being
exhibited 4;

(b) by inserting after the item—

Section 72 (1) Failure to stand 4

the item—

Section 78 (2a) or

(2b) Failure to comply with exhibited stop
sign 4;

(c) by striking out the item—

Section 49 (1) (a) Exceeding 35 m.p.h. 3

and inserting in lieu thereof the item—

Section 49 (1) (a) Exceeding the prescribed speed limit
in a town, etc. 3;

(d) by striking out the item—

Section 49 (1) (d) Exceeding 15 m.p.h. approaching and
within 100ft. of school crossing 3

and inserting in lieu thereof the item—

Section 49 (1) (d) Exceeding the prescribed speed limit
within the prescribed distance of a
school crossing 3;

(e) by striking out the item—

Section 49 (1) (e) Exceeding 15 m.p.h. between signs at
road works, etc. 3

and inserting in lieu thereof the item—

Section 49 (1) (e) Exceeding the prescribed speed limit
between signs at road works, etc... 3;

(f) by striking out the item—

Section 53 (1) and
(2) Exceeding speed—commercial vehicle 3

and inserting in lieu thereof the item—

Section 53 (1) or
(2) Exceeding speed—commercial vehicle 3;

(g) by striking out the item—

Section 78 (1), (2)
and (3) Failing to comply with stop sign.... 3

and inserting in lieu thereof the item—

Section 78 (1), (2)
or (3) Failing to comply with stop sign.... 3;

(h) by striking out the item—

Section 74 (1) and
(1a) Failing to signal divergence, turn,
stopping or slowing down 2

and inserting in lieu thereof the item—

Section 74 (1) Failing to give prescribed signal.... 2;

and

(i) by striking out the items—

Section 111 (1) .. Driving vehicle without prescribed
headlamps (*vide* section 112 (1),
(2) and (3)) 1

Section 111 (1) .. Driving vehicle without prescribed
clearance lamps (*vide* section 117 (2),
(3), (4) and (5)) 1

and inserting in lieu thereof the item—

Section 111 Driving, etc., a vehicle without
prescribed lamps or reflectors 1.
