AN ACT for regulating the Police Force of the Province of South Australia.

HEREAS an Act of the Governor in Council 3rd Victoria No. 6 was passed for raising and organising a Police Force for the Province of South Australia and whereas Her Majesty having been pleased to disallow the said Act it becomes necessary to pass a new enactment providing for the same object on the most moderate scale and limited to the period requisite for receiving Her Majesty's sanction to the establishment proposed to be

BE IT THEREFORE ENACTED BY HIS EXCELLENCY GEORGE GREY Esquire Governor and Commander-in-Chief of her Majesty's Province of South Australia with the advice and consent of the Legislative Council thereof as follows: That until Her Majesty's pleasure shall be known respecting the establishment to be sanctioned for the Police of this Province it shall be lawful for the Governor of this Province for the time being from time to time by warrant under his hand to appoint a Commissioner or Commissioners of Police or such other officers as he may deem expedient for the general superintendence of the Police Force and to execute such other duties as shall be begeinafter specified or as shall be from time to time directed by the Goverfor the time being for the more efficient administration of the Police within the said Province under the authority of this or any other Act or ordinance in force within this Province and the said Commissioners and other officers from time to time to displace and remove and to appoint others in their place as to the said Governor shall seem fit.

II. And also that every person to be appointed a Commissioner or officer Oath to be taken of Police shall before he shall begin to execute the duties of his office take by Superintendent the following outh before the Judge of the Supreme Court of the said Police. Province

III. And also that it shall and may be lawful for the Governor for the time being to make such rules regulations and orders as may seem fit or as occasion shall require for ensuring the proper discipline and efficiency of the said Police Force and the said rules regulations and orders to alter ay vary or annul from time to time as shall seem fit or necessary.

Police for Province appointed.

V. And also that it shall be tawful for the Governor for the time being by and with the advice and consent of the Legislative Council to authorise the said Commissioner or officers from time to time to nominate a sufficient selo number of able men as a Police Force for the said Province who shall be sworn before any Justice of the Feace for this Province to act as Constables een for preserving the peace and preventing robberies and other felonies and ever apprehending offenders in and throughout the said Province and the men so forfer sworn shall have all such powers authorities privileges and advantages as any constable duly appointed now has or hereafter may have by virtue of any law or statute now made or hereafter to be made and shall obey all such lawful commands as they shall from time to time receive from the said Commissioner or other officer respectively for conducting themselves in the execution of their offices and such Commissioner or officer may at any time sus-with pend or dismiss from his employment any such constable whom he shall or a think remiss or negligent in the execution of his duty or otherwise unfit for the the same and when any such constable shall be so dismissed or cease to the belong to the said force all powers and authorities vested in him as a constable under and by virtue of this Act shall immediately cease and determine the to all intents and purposes whatsoever and the men so sworn shall enter such into and subscribe articles of agreement with the said Commissioner binding thri themselves to serve in the Police for such period and under such conditions and regulations as His Excellency the Governor in Council shall from at time to time order and direct and in default of their performance of the best articles of the said agreement and the conditions thereof or in case of distance obedience of such lawful commands as aforesaid the person or persons state neglecting to fulfil the said agreement or being guilty of disobedience of hi orders as aforesaid may be brought before the said Commissioner or an the c two Justices of the Peace appointed by the Governor for the time being thes act for such Commissioner or officer of Police and being convicted of such and neglect and disobedience shall for every such offence forfeit and pay a sureth not less than five shillings nor exceeding twenty pounds and shall addition to such fine or in default of payment thereof be liable to imprisoned for not less than one week nor more than six calendar month Re in any common gaol or place of confinement within this Province.

And also that any person employed in the said Police Force shall take a bribe or any gratuity whatever for suffering a prisoner ales any offender against any of the laws in force within this Province to escentible id r for neglecting to execute any warrant or law process entrusted to hin. or ar o make any seizure or for in any way showing favor to a prisoner or ny ffender of whatever kind or description shall upon summary conviction er hereof before one or more Justice or Justices of the Peace be subject to fine not exceeding fifty pounds or to imprisonment for any period not he acceding six months or to both fine and imprisonment in the discretion the said Justice or Justices.

IX. And also that if any person shall assault or resist any person be refi longing to the said Police Force in execution of his duty or shall aid or her incite any person so to assault or resist every such offender being convicted per thereof in a summary way before a Justice of the Peace shall for every and such offence forfeit and pay a sum not less than five pounds nor exceeding tion ten pounds or shall in the discretion of such Justice be committed to take evihis or her trial before the Resident Magistrate of the district wherein the req offence has been committed or at the next General Gaol Delivery.

Penalty on publicans harbouring policemen during the hours of duty.

X. And also that if any victualler or licensed publican or other person bef shall knowingly harbour or entertain any man belonging to the said Police this Force or permit such man to abide or remain in his house shop room or other won place during any part of the time appointed for his being on duty elsewhere or after the hours appointed for closing the said public houses by the Lor Act of Council No. 1, 2nd Victoriæ unless such constable shall have entered the said house for the bona fide execution of his duty and shall may remain there so long only as shall be requisite in that behalf every such An victualler licensed publican or other person being convicted thereof in s hat summary way before a Justice of the Peace shall for every such offence forfeit and pay a sum not exceeding five pounds. alre

Jurisdiction proceedure for offences.

XI. And also that all complaints of offences against this Act shall be heard and determined and all fines penalties and forfeitures may be recovered by summary proceedure before such Justice or Justices or Resident Ma gistrate who shall have power in all cases to award costs if he shall think form proper and such fines penalties and forfeitures with such costs if awarded war may be levied by distress and sale and in default of payment and prov sufficient distress such Justice or Justices or Resident Magistrate may by that warrant commit the offender to the common gaol of the province there to dist remain and be imprisoned either simply or to be kept to hard labor in the solitary confinement or both in the discretion of such magistrate for any time a tre not exceeding the time hereinafter mentioned that is to say not exceeding right seven clear days where the whole sum to be levied or remaining unpaid part together with the costs shall not exceed ten shillings for a term not exceed ten shillings for a term not exceed ceeding fourteen clear days where the said sum and costs shall not exceed Irres one pound for a term not exceeding one calendar month where the said sum and costs shall not exceed five pounds and for a term not exceeding three calendar months where the said sum and costs shall be of any greater amount unless the said sum to be levied together with the cost this shall be sooner paid. agaiı

XII. And also that it shall and may be lawful to or for any Justice of Resident Magistrate as aforesaid to issue a summons under his hand any person whomsoever to attend as a witness to give evidence upon oath solemn affirmation before such Justice or Resident Magistrate touching Pieac matter of fact contained in any information or complaint for any offens at ar against this Act whether on the part of the prosecutor or informer of actio the person complained of and which summons such Justine or Resident Magistrate as aforesaid is hereby required to issue if demanded and if

XIII. And also that every Justice of the Peace or Resident Magistrate before whom any person or persons shall be convicted of any offence against ice this Act shall and may cause the conviction to be drawn up in the following ner words or in words to the same effect: That is to say-

XIV. And also that no conviction order warrant or other matter made or No certiorari. purporting to be made by virtue of this Act shall be quashed for want of k form or removed by certiorari or otherwise into the Supreme Court and no warrant of commitment shall be held void by reason of any defect therein provided that it be therein alleged that the party has been convicted and that there be a good and valid conviction to sustain the same and where any distress shall be made for levying any money by virtue of this Act the distress itself shall not be deemed unlawful nor the party making the same be deemed a trespasser on account of any defect or want of form in the summons conviction warrant of distress or other proceedings relating thereto nor shall the party distraining be deemed a trespasser ab initio on account of any irregularity afterwards committed by him but the person aggrieved by such inegularity may recover full satisfaction for the special damage if any in an action upon the case.

XV. And also for the protection of persons acting in the execution of As to proceedings this Act be it enacted that all actions and prosecutions to be commenced against against any person for anything done in pursuance of this Act shall Act. be commenced within two calendar months after the fact committed and not otherwise and notice in writing of such action and of the cause Notice of action. thereof shall be given to the defendant one calendar month at least before the commencement of the action and in any such action the defendant may plead the general issue and give this Act and the special matter in evidence at any trial to be had thereupon and no plaintiff shall recover in any such action if tender of sufficient amends shall have been made before such action brought or if a sufficient sum of money shall have been paid into Court after such action brought by or on behalf of the defendant together with the costs incurred up to that time and if a verdict shall pass for the defendant or the plaintiff become non-suited or discontinue any such action After issue joined or if upon demurrer or otherwise judgment shall be given

against the plaintiff the defendant shall recover his full costs as betwee attorney and client and have the like remedy for the same as any defendant hath by law in other cases and though a verdict shall be given for the plaintiff in any such action such plaintiff shall not have costs against the defendant unless the Judge before whom the trial shall be had shall certifichis approbation of the action and of the verdict obtained thereupon.

Appropriation of Fines.

XVI. And also be it further enacted that all fines and penalties which make recovered by virtue of this Act shall be given and paid one third the informer or 'prosecutor if demanded and the residue to the use of He Majesty Her Heirs and Successors for the public uses of this Province and for the support of the Government thereof.

XVII. And also that where any person employed in the said Police Force shall be entitled to the whole or a proportion of any forfeiture penalty of seizure under this or any other act in force within this Province the amount or proceeds thereof shall go to a general fund to be distributed at the end of every year among the officers and men belonging to the said Police Force in such proportions and according to such regulations as the Governor for the time being shall appoint direct and determine and in defaul of appointing regulations or directions being made the said fine shall go to the person entitled to the same immediately upon the recovery thereof.

XVIII. And also be it further enacted that this Act shall commence at take effect from and after the passing thereof.

XIX. And also that in this Act unless where otherwise required by the context the words "party" or "person" shall extend to males and females and all words in the singular shall extend to the plural number and all words of the masculine gender to the feminine.
