An Act to Amend the Phylloxera Acts, 1899 to 1922, and for other purposes.

[Assented to, October 14th, 1926.]

BE it enacted by the Governor of the State of South Australia, with the advice and consent of the B. with the advice and consent of the Parliament thereof, as follows:

- 1. (1) This Act may be cited as the "Phylloxera Act Amend-Short titles. ment Act, 1926".
- (2) The Phylloxera Acts, 1899 to 1922, and this Act may be cited together as the "Phylloxera Acts, 1899 to 1926".
- (3) The Phylloxera Act, 1899, is hereinafter referred to as "the No. 724 of 1899. principal Act."
- 2. This Act is incorporated with the other Acts mentioned in Incorporation. section 1 of this Act, and those Acts and this Act shall be read as one Act.
- 3. Notwithstanding anything contained in the Phylloxera Acts, Validation of 1899 to 1922, the persons mentioned in the Schedule hereto shall appointment of members of Board, be and be deemed to be elective members of the Board and shall be deemed to have been elective members as aforesaid from the dates set forth in the Schedule hereto and to have been elected in respect of the districts set forth in the Schedule hereto.

Phylloxera Act Amendment Act.—1926.

Election of member for No. 7 district.

- 4. (1) There shall be an election of the elective member of the Board for the district numbered 7 within two months after the passing of this Act.
- (2) Nominations shall be in the hands of the Secretary within one month after the passing of this Act.
- (3) Save as aforesaid, the said election shall be subject to the provisions of sections 8 and 9 of the principal Act.

Election of Board.

- 5. (1) An election of elective members of the Board shall be held pursuant to the principal Act during the year nineteen hundred and twenty-seven for the districts numbered 1, 2, 3, and 4.
- (2) An election of elective members of the Board shall be held pursuant to the principal Act during the year nineteen hundred and twenty-eight for the districts numbered 5, 6, and 7.
- (3) The term of office of the elective members of the Board referred to in the Schedule hereto and of the elective member of the Board elected pursuant to section 4 shall respectively expire on the notification by the Minister in the Government Gazette of the election pursuant to this section of elective members of the Board for the respective districts represented by such first mentioned elective members.
- (4) Any elective member of the Board referred to in the Schedule hereto or elected pursuant to section 4 shall be eligible for election under this section.

Validation of acts of Board.

- 6. All acts and proceedings before the passing of this Act of the persons constituting the Board or of any persons purporting to constitute the Board shall be deemed to have been a lawful exercise of the powers conferred by the Acts incorporated with this Act and no act or proceeding thereof shall be invalid or prejudiced by reason of the fact that, at the time when the act or proceeding was done, taken, or commenced, the Board was not properly constituted or that any person purporting to act as an elective member thereof was not properly elected thereto.
- In the name and on behalf of His Majesty, I hereby assent to this Bill.
