*An Act to provide additional Railway Accommodation at Port Adelaide and Alberton.*

[Assented to, 17th September, 1873.]

**W**HEREAS it is expedient to provide for additional railway Preamble.  
accommodation at Port Adelaide and Alberton in connexion with the City and Port Railway and the acquiring of certain lands situated at or near to Port Adelaide and Alberton therefor: And whereas plans showing the lands proposed to be acquired, signed "H. C. Mais, dated 11-8-73," together with the book of reference thereto, have been duly prepared and deposited in the office of the Surveyor-General, at Adelaide—Be it therefore Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said Province, in this present Parliament assembled, as follows:

1. This Act may be cited for all purposes as "The Adelaide and Short title.  
Port Railway Extended Accommodation Act, 1873."

2. "The Lands Clauses Consolidation Act," No. 6 of 1847; "The Incorporation.  
Railways Clauses Consolidation Act," No. 7 of 1847; "The Railways Clauses Consolidation Act," No. 6 of 1858, so far as the same are severally applicable to this Act; "The Adelaide City and Port Railway Act," No. 1 of 1850; "An Act to authorize the appointment of Undertakers for the Construction of the Adelaide City and Port Railway," No. 1 of 1851; and "The Railway Commissioners Act," No. 11 of 1859, shall be incorporated therewith, and this Act and the said Acts shall be read and construed together accordingly.

3. The

*Adelaide and Port Railway Extended Accommodation Act.—1873.*

Power to acquire lands and erect buildings.

3. The Commissioner of Railways may enter upon, use, take, and acquire the lands delineated and referred to in the plans showing the lands proposed to be so taken, signed by the Engineer-in-Chief, and deposited in the office of the Surveyor-General, at Adelaide, as aforesaid, or so much thereof as shall be or be deemed necessary.

Commissioner may enter and take lands.

4. The said Commissioner may erect, make, and maintain upon the lands so taken or acquired such buildings, erections, works, and conveniences connected therewith as are also shown in the said plans.

May have power of Commissioners under Road Act.

5. The said Commissioner shall, with respect to all roads shown upon the said plans, have all the rights, authorities, and powers of Commissioners of Roads under an Act, No. 17 of 1852, "For the making and improving of Roads in South Australia," and the "Roads Amendment Act, 1863."

Exemption from local rates.

6. The lands hereby authorized to be taken and acquired, and the erections by this Act authorized to be constructed shall be, and are hereby declared to be, exempt from sewers, highway, municipal, police, improvement, and all other local rates and taxes.

In the name and on behalf of Her Majesty the Queen I hereby assent to this Bill.
