An Act to complete the Exchange of certain Poonindie Lands.

[Assented to, December 20th, 1895.]

WHEREAS it is expedient that this Act should be passed for the purpose of completing an exchange of certain Poonindie lands which has been arranged between the Government of South Australia and the Trustees of the Poonindie Native Institution—Be it Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province, in this present Parliament assembled, as follows:

Preamble.

1. The lands described in the First Schedule hereto are hereby vested in Her Majesty the Queen as Crown lands, and discharged from all previous trusts.

Vesting of lands in Crown.

2. The lands described in the Second Schedule hereto are hereby vested in the Right Reverend John Reginald Harmer, of Adelaide, Doctor in Divinity, Sir Samuel Davenport, of Adelaide, K.C.M.G., and Edwin Gordon Blackmore, of Adelaide, Esquire, as joint tenants for an estate in fee-simple.

Vesting of lands in Trustees.

3. The said Right Reverend John Reginald Harmer, Sir Samuel Davenport, and Edwin Gordon Blackmore, or other the trustees of the said land, notwithstanding any trust affecting the same, may sell, convey, or dispose of the land mentioned in the Second Schedule as absolute owners, but so that the purchase-money shall be applicable to the benefit of the aboriginal natives and half-castes of the aboriginal race of South Australia on trusts to be declared by the said Right Reverend

Sale and disposal of lands.

Poonindie Exchange Act.—1895.

Reverend John Reginald Harmer, Sir Samuel Davenport, and Edwin Gordon Blackmore, but so also that, so far as regards the protection of purchasers and others dealing with the said land, their ownership of the said land and of the purchase-money thereof shall be deemed absolute and without exception.

Short title.

4. This Act may be cited as "The Poonindie Exchange Act, 1895."

THE FIRST SCHEDULE.

Sections 117, 129, and 282, in the hundred of Louth, county of Flinders, containing altogether two hundred and thirty-nine acres, or thereabouts.

THE SECOND SCHEDULE.

Sections 125, 126, and 127, in the said hundred of Louth, containing two hundred and forty-four acres, or thereabouts.

Part section 189, in the said hundred of Louth, containing two acres and eighteen perches, or thereabouts, and particularly described in certificate of title vol. ccxxv., fol. 21.
