An Act to provide for the filing in the Office of the Registrar of Companies of certain Documents now required to be filed in the Supreme Court, to transfer to the Registrar of Companies certain Functions now performed by the Master of the Supreme Court, and to make the necessary amendments to the Banking Companies Act, 1863, the Associations Incorporation Act, 1890, and the Public Library, Museum, and Art Gallery, and Institutes Act, 1909.

[Assented to, December 18th, 1924.]

BE it Enacted by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :

1. This Act may be cited as the "Registrar of Companies (Miscellaneous Functions) Act, 1924." Short title.

2. Wherever by any provision of the Banking Companies Act, 1863, the Associations Incorporation Act, 1890, or the Public Library, Museum, and Art Gallery, and Institutes Act, 1909, it is provided that any deed, memorial, or document whatsoever is to be or may be filed, deposited, or registered in the Supreme Court, that provision shall hereafter be read and construed as providing that the deed, memorial, or document therein referred to is to be or may be filed, deposited, or registered in the office of the Registrar of Companies, and all the functions of the Master of the Supreme Court in connection with the filing, depositing, or registering of any such deed, memorial, Filing of documents in office of Registrar of Companies in lieu of Supreme Court.

3. All deeds, memorials and documents filed, deposited or registered in the Supreme Court before the passing of this Act under any of the Acts mentioned in the next preceding section shall be deemed to have been filed, deposited or registered, as the case may be, in the office of the Registrar of Companies, and the Registrar of Companies shall hereafter have the custody and control of the said deeds, memorials and documents, and shall hereafter perform all the functions heretofore performed by the Master of the Supreme Court in connection with the said deeds, memorials and documents.

Amendments of
certain Acts.

4. For the purpose of giving effect to the provisions of section 2 of this Act the Acts mentioned in that section are amended in the manner set forth in the Schedule to this Act.
