An Act to amend the Business Franchise (Petroleum Products) Act 1979, the Commercial Motor Vehicles (Hours of Driving) Act 1973, the Dangerous Substances Act 1979, the Education Act 1972, the Explosives Act 1972, the Financial Institutions Duty Act 1983, the Food Act 1985, the Industrial Relations Act (S.A.) 1972, the Land Tax Act 1936, the Lifts and Cranes Act 1985, the Liquor Licensing Act 1985, the National Parks and Wildlife Act 1972, the Noise Control Act 1976, the Pastoral Land Management and Conservation Act 1989, the Pay-roll Tax Act 1971, the Public and Environmental Health Act 1987, the South Australian Metropolitan Fire Service Act 1936, the Stamp Duties Act 1923, the Tobacco Products Control Act 1986, the Unclaimed Moneys Act 1891 and the Valuation of Land Act 1971.

The Parliament of South Australia enacts as follows:

## Short title

1. This Act may be cited as the Statutes Amendment (Expiation of Offences) Act 1992.

#### Commencement

2. This Act will come into operation on a day to be fixed by proclamation.

## Amendment of Acts specified in the schedule

- 3. (1) The Acts specified in the schedule are amended by inserting at the foot of each provision referred to in that schedule (and after any item that relates to penalty) the item that appears in the schedule opposite the reference to that provision.
- (2) If an Act sought to be amended by this Act is, before the commencement of this Act or the commencement of a particular item in this Act, amended in a manner that renders an amendment sought by this Act ineffective, the amendment sought by this Act will be taken to have been struck out.
