An Act to amend the Agent-General Act, 1901-1953, the Audit Act, 1921-1966, the Industrial Code, 1920-1966, the Police Regulation Act, 1952-1966, the Public Service Act, 1936-1966, and the Public Service Arbitration Act, 1961-1964, and for other purposes.

[Assented to 14th September, 1967]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :

Short title.

1. This Act may be cited as the "Statutes Amendment (Public Salaries) Act, 1967".

2. Subsection (1) of section 5 of the Agent-General Act, 1901-1953, as amended from time to time, is amended—

(a) by striking out the passage "four thousand five hundred pounds sterling a year until the twentieth day of March, one thousand nine hundred and sixty-six and thereafter at the rate of four thousand and eighty pounds sterling a year" therein and inserting in lieu thereof the passage "four thousand four hundred and sixty pounds sterling a year";

and

(b) by striking out the passage "one thousand pounds sterling a year until the twentieth day of March, one thousand nine hundred and sixty-six and thereafter at the rate of one thousand nine hundred

and twenty pounds sterling a year" therein and inserting in lieu thereof the passage "two thousand one hundred pounds sterling a year".

3. Subsection (1) of section 6 of the Audit Act, 1921-1966, is amended by striking out the passage "five thousand eight hundred pounds" therein and inserting in lieu thereof the passage "thirteen thousand dollars".

4. Subsection (1) of section 13 of the Industrial Code, 1920-1966, is amended by striking out the passage "five thousand six hundred and fifty pounds" therein and inserting in lieu thereof the passage "thirteen thousand dollars".

5. Section 8 of the Police Regulation Act, 1952-1966, is amended—

(a) by striking out the passage "five thousand four hundred pounds" in subsection (1) thereof and inserting in lieu thereof the passage "twelve thousand two hundred dollars";

and

(b) by striking out the passage "fifty-five pounds" in subsection (2) thereof and inserting in lieu thereof the passage "one hundred and twenty dollars".

6. Subsection (1) of section 17 of the Public Service Act, 1936-1966, is amended by striking out the passage "five thousand eight hundred pounds" therein and inserting in lieu thereof the passage "thirteen thousand dollars".

7. Subsection (1) of section 4 of the Public Service Arbitration Act, 1961-1964, as amended from time to time, is amended by striking out the symbol and figures "£5,100" wherever occurring therein and inserting in lieu thereof in each case the passage "eleven thousand four hundred dollars".

8. The amendments made by this Act shall be deemed to have come into operation on the first day of July, 1967.

9. (1) The arrears of salary payable to any person by virtue of this Act may be paid in one sum.

(2) This Act shall, without further appropriation, be sufficient authority for the payment of all such arrears.
