An Act to revise further the Statute Law and for other purposes.

[Assented to, 26th November, 1936.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :

1. This Act may be cited as the " Statute Law Revision Act (No. 2), 1936 ". Short title.

2. (1) The enactments named in the schedule to this Act are hereby repealed. Repeal of certain Acts.

(2) If the Governor is of opinion that any enactment repealed by this section should be revived, the Governor may by proclamation declare that enactment to be revived, and thereupon that enactment shall be deemed to be revived and to have continued in force as from the date of the repeal thereof by this section, but no person shall be subjected to any criminal proceedings in respect of anything done subsequent to such repeal and prior to any such revival.

3. (1) Any repeal under section 2 shall not affect— Saving provision.

(a) the validity or invalidity of anything done or suffered before the repeal :

(b) the validity or invalidity of anything declared to be valid or invalid by any enactment so repealed :

- (c) any right, interest, title, power, or privilege existing or accruing under any enactment so repealed :
- (d) the proof of any past act or thing :
- (e) the recognition in South Australia under any enactment so repealed of any status, right, title, or other matter or thing elsewhere acquired in the same circumstances and to the same extent as such recognition would have been granted or given prior to the passing of this Act.

(2) Without limiting the effect of subsection (1) of this section it is declared that notwithstanding the repeals effected by section 2 every right, power, and privilege which under any public securities in existence at the commencement of this Act is vested in any person, or would, if the Acts repealed by this Act had remained in force, have accrued to any person, shall continue in full force and effect, or, as the case may be, shall accrue to that person, as if the repealed Acts had remained in force.

(3) This section shall not limit the application of any provision of the Acts Interpretation Act, 1915, to any such repeal.
