An Act to amend the Correctional Services Act, 1982, the South Australian Heritage Act, 1975, and the State Transport Authority Act, 1974.

[Assented to 4 May 1989]

The Parliament of South Australia enacts as follows:

Short title

1. This Act may be cited as the Statute Law Revision Act, 1989.

Commencement

2. This Act will come into operation on a day to be fixed by proclamation.

Amendment of Acts specified in the schedules

- 3. (1) The Acts specified in the first column of the schedules to this Act are amended in the manner indicated in the second column of the schedules.
- (2) If an Act sought to be amended by a schedule to this Act is, before the commencement of that schedule, amended in a manner that renders an amendment contained in the schedule ineffective, that amendment will be taken to have been struck out.
