# GEORGII V REGIS.

A.D. 1912.

## No. 1095.

An Act to authorise the construction of certain Works for the Storage and Distribution of Water, to amend The Barossa Waterworks Act, 1902, and The Bundaleer Waterworks Act, 1902, and for other purposes.

## [Assented to, December 12th, 1912.]

BE it Enacted by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. This Act may be cited as "The Warren Reservoir Act, 1912." Short title.
- 2. This Act is incorporated with "The Waterworks Act, 1882," Acts incorporated. and all Acts incorporated with that Act except sections 110, 114, No. 269 of 1882. 115, 116, 117, and 118 of "The Lands Clauses Consolidation Act." No. 6 of 1847.
- 3. The Commissioner of Waterworks may, out of any moneys commissioner of voted by Parliament for the purpose—

(a) Construct and maintain the waterworks known as the Scheme. Warren Reservoir Water Scheme, and all other works which from time to time are found to be necessary or convenient in connection therewith, within the water district to be called the "Warren Water District," shown and margined green on the plan deposited on the twenty-ninth day of November, nineteen hundred and twelve, in the office of the Surveyor-General, marked "The Mount Crawford Reservoir Water Scheme, Mount Crawford Water District," signed "Charles A. Bayer, Hydraulic Engineer,"

Engineer," and dated the twenty-ninth day of August, nineteen hundred and twelve, and within the catchment area shown and margined red on the said plan, and

(b) Construct and maintain such works and do such things as from time to time are found to be necessary or convenient for conveying and distributing the water stored in the said waterworks to and through the districts and area to be supplied therewith.

Districts which may be supplied.

- 4. The water stored in the said waterworks may be used—
  - (a) For the further supply of the water district mentioned in "The Barossa Waterworks Act, 1902,"
  - (b) For the supply of the Warren Water District,
  - (c) For the further supply of the water district mentioned in "The Bundaleer Waterworks Act, 1902," and
  - (d) For the further supply of the water area constituted by "The Kapunda Waterworks Act, 1877."

Warren Water District constituted a water district under the Waterworks Act. 5. (1) The Warren Water District (as the meaning of that term is defined in section 6 of this Act) is hereby constituted and declared to be a water district for the purposes of "The Waterworks Act, 1882."

Barossa and Bundaleer Districts declared water districts under the Waterworks Act. (2) The water districts mentioned in "The Barossa Waterworks Act, 1902," and "The Bundaleer Waterworks Act, 1902," respectively (as the meaning of those terms is defined in section 6 of this Act) are hereby declared to be water districts for the purposes of "The Waterworks Act, 1882," and all proclamations heretofore or hereafter made and published, and all other matters and things heretofore or hereafter done or omitted, shall be deemed to have been and shall be as valid, and shall have the same effect, as if the said water districts had by the said Acts respectively been constituted and declared to be water districts for the purposes of "The Waterworks Act, 1882."

Meaning of water district in this Act.

6. When any water district is mentioned in this Act it shall be deemed to mean such district with any additions which at the time have been made thereto by proclamation under "The Waterworks Act, 1882," or such district as the same for the time being exists in consequence of any alterations of the boundaries thereof so made.

Part of Warren Water District not deemed to be therein until after petition in that behalf. 7. (1) Notwithstanding anything in this Act, the part of the Warren Water District which lies to the northward of the purple line shown on the said plan, and running through the Hundreds of Alma, Gilbert, and Kapunda, shall not be deemed to be within the said District until a petition has been received by the Commissioner requesting that the said part be included within the operation of this Act, which petition bears the signatures of a majority of the additional

additional persons who will, if the said part is so included, be liable to be rated under the provisions of "The Waterworks Act, 1882," and is certified by the Commissioner to be signed by such a majority of persons.

(2) Upon certifying as aforesaid, the Commissioner shall cause a notice to be published in the *Government Gazette* stating that, from a date mentioned therein, the said part shall be included in such District, and, from the said date, the said part shall, for all purposes, be included in and be part of the said District.
