# VICTORIÆ REGINÆ.

*An Act to authorise the construction of a high-level Reservoir and other works for the purpose of extending the supply of water to Burnside and other places.*

[Assented to, 30th November, 1878.]

**W**HEREAS it is desirable to authorise the construction of a high-level reservoir and other works, for the purpose of extending the supply of water to the places mentioned in the Schedule hereto: And whereas plans and sections showing the source of supply, and the reservoir and other works, and the direction of the main and branch pipes, and the streets and grounds through which they are to be laid, and also books of reference containing the names of the owners or occupiers, or reputed owners or occupiers (so far as known), of any private land on which the said reservoir or other works will be constructed, or through which the same will pass, have been deposited in the office of the Surveyor-General, at Adelaide—Be it therefore Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province, in this present Parliament assembled, as follows:

Preamble.

1. The Commissioner of Waterworks may construct, out of any moneys which have been or hereafter may be voted by Parliament for this purpose, a high-level reservoir, and other works, according to the plans and sections deposited in the office of the Surveyor-General, at Adelaide.

Commissioner of Waterworks may construct high-level reservoir and other works.

2. If any error, omission, misstatement, or wrong description shall have been made of any lands or streams, or of the owners or occupiers, or reputed owners or occupiers, of any lands or streams

Errors and omissions in plans, &c., may be corrected by justices, &c.

streams delineated or shown on the said plans or sections, or described in the books of reference deposited as aforesaid, the Commissioner of Waterworks, after giving ten days' notice to the owners or occupiers, or reputed owners or occupiers, of the lands and streams affected, or likely to be affected, by the correction of such error, omission, misstatement, or wrong description, may apply to two justices to correct the same; and, if it shall appear to such justices that it is expedient and not unjust to correct such error, omission, misstatement, or wrong description, they shall give the said Commissioner a certificate in such form as they shall think proper, and shall in such certificate state the particulars of any such error, omission, misstatement, or wrong description; and such certificate, with the documents to which it refers, shall be deposited with the other documents to which they refer, in the office of the Surveyor-General, and thereupon such plans, sections, or book of reference shall be deemed to be corrected according to such certificate, and the said Commissioner may make, complete, extend, and maintain the works hereby authorised, in accordance with such certificate, as if such error omission, misstatement, or wrong description had not been made.

Surveyor-General to receive plans and allow inspection.

3. The Surveyor-General shall keep the said plans and sections, and books of reference, and all other documents deposited with him, for the purposes of this Act, and shall allow all persons interested to inspect any of the documents aforesaid, and to make copies and extracts of and from the same.

Interpretation.

4. In the construction of, and for the purposes of this Act and "The Adelaide City, Port, and Suburban Waterworks Act, 1874," when not inconsistent with the context, the expression, the "undertaking" shall, in addition to the meaning assigned thereto by the said "The Adelaide City, Port, and Suburban Waterworks Act, 1874," mean and include the high-level reservoir and other works hereby authorised to be constructed; and the expression, "lands and streams" shall, in addition to the meaning assigned thereto by the said Act, mean and include the land and streams of water hereby authorised to be taken or used for the purposes hereof.

Short title.

5. This Act may be cited for all purposes as "The Waterworks Amendment Act, 1878."

Incorporation.

6. Except so far as the same is inconsistent with or altered by this Act, this Act and "The Adelaide City, Port and Suburban Waterworks Act," shall be incorporated and read as one Act.

## SCHEDULE REFERRED TO.

## DISTRICT OF BURNSIDE.

Comprising the whole of preliminary sections 273, 274, 275, 291, 292, 297, 298, 299, 300, 301, 319, 320, and portions of 288 and 296; also sections 269 and 2040, in the Hundred of Adelaide, bounded as follows:—Commencing at the north-eastern corner of preliminary section 262; thence easterly along the southern side of road south of section 276, to the north-eastern corner of section 275; thence southerly along the western side of road west of section 290, to the south eastern corner of Section 275; thence across the road, and along the southern boundary of section 290 to its south-eastern corner; thence northerly along the eastern boundaries of preliminary sections 290, 289, and 288, to a point on the eastern boundary of the latter section 1,670 links from its north-eastern corner; thence westerly at right angles to a point 200 links east of its western boundary; thence in a north-easterly direction to a point on the south side of road south of section 287, 1,700 links from the north-western corner of section 288; thence easterly along the southern side of said road to the north-east corner of section 301; thence southerly along the western side of road west of sections 272, 271, and 270, to a point opposite the south-western corner of the latter section; thence easterly across the road, and along the southern boundary of said section to its south-eastern corner; thence southerly along the western boundaries of sections 288, 289, and 290, and western side of road west of portion of section 904 to the south-eastern corner of section 320; thence westerly along northern side of road north of portion of section 903 to a point opposite the north-eastern corner of section 269; thence southerly across the road and along the eastern boundary of said section to the north-eastern corner of section 268; thence westerly along the northern boundary of said section, and across the road to the south-eastern corner of section 297; thence southerly along west side of road west of section 268 for 22 chains; thence south-westerly to a point on the north boundary of section 266, 30 chains east of its north-western corner; thence westerly to the north-western corner of said section, and across the road to the south-eastern corner of section 293; thence northerly along the eastern boundary of said section to its north-eastern corner; thence westerly along northern boundaries of sections 293 and 272 to the north-western corner of the latter section; thence northerly along the eastern boundaries of sections 264, 263, and 262 to the point of commencement.
