AN ACT for applying certain Sums arising from the General Revenue of the Colony of *Tasmania* to the Service thereof for Nine Months of the Year One thousand eight hundred and fifty-seven ending 30th *September* and for further appropriating the said Revenue. [5 *June*, 1857.]

**B**E it enacted by the Governor of *Tasmania* by and with the advice and consent of the Legislative Council and House of Assembly in Parliament assembled as follows—

**1** Out of the General Revenue of the Colony of *Tasmania* there shall and may be appropriated to the Public Service within the said Colony and issued and applied any sum of money not exceeding Eighty-nine thousand one hundred and ninety-three pounds four shillings and nine pence to defray the salaries allowances and contingencies of the Civil Legislative and Judicial Departments of the said Colony for nine months

of the year one thousand eight hundred and fifty-seven ending 30th *September* as hereinafter more particularly expressed—that is to say—any sum or sums of money not exceeding Seventy-five pounds to defray the salary of the Clerk of the Executive Council and any sum or sums of money not exceeding Three thousand three hundred and seventy-five pounds fifteen shillings to defray the salaries allowances and contingencies of the Houses of Legislature and any sum or sums of money not exceeding One thousand three hundred and eighty-seven pounds ten shillings to defray the salaries and contingencies of the Department of the Colonial Secretary and any sum or sums of money not exceeding One thousand three hundred and ninety-five pounds to defray the salaries of the Department of the Colonial Treasurer and any sum or sums of money not exceeding One thousand one hundred and seventy pounds to defray the salaries of the Department of the Auditor and any sum or sums of money not exceeding Five thousand six hundred and thirty-six pounds five shillings and ten pence to defray the salaries and contingencies of the Customs' Department and any sum or sums of money not exceeding Two thousand nine hundred and seventy-nine pounds to defray the salaries allowances and contingencies of the Survey Department and any sum or sums of money not exceeding Four thousand four hundred and thirty-two pounds thirteen shillings and nine pence to defray the salaries and contingencies of the Post Office Establishment and any sum or sums of money not exceeding Eight hundred and thirty-six pounds five shillings to defray the salaries and contingencies of the Department of the Accountant of Stores and any sum or sums of money not exceeding Six thousand and twenty pounds five shillings to defray the salaries of the Marine Department and any sum or sums of money not exceeding One thousand eight hundred and ninety-seven pounds ten shillings to defray the salaries and allowances of the Department of Public Works and any sum or sums of money not exceeding One thousand and two pounds fifteen shillings to defray the salaries allowances and contingencies of the Immigration Department and any sum or sums of money not exceeding Three thousand one hundred and ninety-eight pounds fifteen shillings to defray the salaries allowances and contingencies of the Establishment of the Government Printer and any sum or sums of money not exceeding One hundred and eighty pounds to defray the salaries and contingencies of the Department of the Commissioners for investigating Titles to Land and any sum or sums of money not exceeding One hundred and sixty-five pounds to defray the salaries and contingencies of the Aborigines' Establishment and any sum or sums of money not exceeding Three hundred pounds to defray the salary and allowances of the Department of the Registrar of Births Deaths and Marriages and any sum or sums of money not exceeding Seven hundred and fifty pounds to defray the allowances for Coroners' Inquests and any sum or sums of money not exceeding Sixty-seven pounds ten shillings to defray the salaries of the Inspectors of Weights and Measures and any sum or sums of money not exceeding Fifty-six pounds five shillings to defray the salary of the Inspector of Stock Hobart Town and any sum or sums of money not exceeding Two thousand and nineteen pounds to defray the salaries and allowances on account of the Lunatic Asylum New Norfolk and any sum or sums of money not exceeding One thousand one hundred and forty-seven pounds ten shillings to defray the salaries and allowances of the Boards of Education and any sum or sums of money not exceeding One hundred and twenty pounds to defray the salaries of the Miscellaneous Establishment and any sum or sums of money not exceeding One hundred and fifty pounds to defray the salary

of the Agent-General in London and any sum or sums of money not exceeding Forty-four thousand nine hundred and forty-four pounds three shillings and sixpence to defray the salaries allowances and contingencies of the Police and Gaols' Establishment and any sum or sums of money not exceeding Five thousand eight hundred and eighty-seven pounds two shillings and sixpence to defray the salaries allowances and contingencies of the Judicial Establishment.

**2** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Four hundred and eighty-one pounds two shillings and three pence to defray the charge for Pensions Retired Allowances and Gratuities for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**3** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding One thousand two hundred and ninety pounds to defray the charge for Revenue Services (exclusive of Establishment) of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**4** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Three thousand one hundred and ninety-five pounds to defray the charge for the Administration of Justice in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**5** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Ten thousand nine hundred and twelve pounds ten shillings to defray the charge for Charitable Allowances of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**6** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Nine thousand pounds to defray the charge for Education (exclusive of Establishment) of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**7** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Three hundred and seventy-eight pounds fifteen shillings to defray the charge of Police and Gaols (exclusive of Establishment) of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**8** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding One thousand

four hundred and sixty pounds eighteen shillings and eleven pence to defray the charge of Rent in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**9** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Two thousand six hundred and eighty-eight pounds fifteen shillings to defray the charge of Transport in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**10** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Thirteen thousand two hundred and seventy-five pounds to defray the charge of Conveyance of Mails of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**11** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Nine thousand three hundred and twenty pounds five shillings to defray the charge of Works and Buildings in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**12** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Thirty-two thousand two hundred and fifty pounds to defray the charge of Roads Streets *et cetera* in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**13** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Six thousand seven hundred and forty-one pounds five shillings to defray Miscellaneous Charges of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**14** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Seven thousand eight hundred and fifteen pounds to defray the charge of Interest due by the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**15** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding One thousand three hundred and eighty-seven pounds ten shillings to defray the charge of Grants in aid of Public Institutions of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**16** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and

issued and applied any sum or sums of money not exceeding One thousand five hundred pounds to defray the charge of Drawbacks in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**17** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Four thousand five hundred pounds to defray the charge of Survey (exclusive of Establishment) of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**18** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Two thousand two hundred and fifty pounds to defray the charge for Assessments in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**19** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Three hundred and twenty-one pounds to defray the charge of Immigration (exclusive of Establishment) of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**20** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Six thousand pounds to defray the charge for Convict Discipline in the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**21** Out of the General Revenue of the said Colony there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding Twenty-thousand seven hundred and sixty-four pounds ten shillings to defray the charge of Accountant of Stores (exclusive of Establishment) of the said Colony for nine months of the year one thousand eight hundred and fifty-seven ending 30th *September*.

**22** The Treasurer of the said Colony shall issue and pay the said several sums to such persons for the purposes hereinbefore mentioned upon such days and in such proportions as the Governor for the time being by any Warrant or Order in writing to be signed by him shall from time to time order and direct and the payments so to be made shall be charged upon and payable out of the Revenue of the said Colony.

**23** The said Treasurer shall in his Accounts from time to time be allowed credit for any sum or sums of money paid by him in pursuance of such Order or Warrant in writing as aforesaid and the receipt or receipts of the respective persons to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said Accounts for any such sum or sums as shall be therein mentioned and he shall receive credit for the same accordingly.
