“the jetty” means any jetty built in the Port of Naracoopa by the Crown partly out of moneys provided by the Company together with the appurtenances thereof;

“the Minister” means the Minister administering the *Marine Act 1921*.

3—(1) The Crown may let and the Board, anything to the contrary in the *Marine Act 1921* notwithstanding, may take the jetty for a term of years at a rent and on conditions proper to or convenient with the above recited proposal.

(2) The *Crown Lands Act 1935* does not apply to any lease to the Board under this section.

(3) The *Roads and Jetties Act 1935* does not apply to the jetty.

4 Notwithstanding any rule of law or provision of the *Marine Act 1921* to the contrary the Board may, with the approval of the Minister, give a preference or an advantage to the Company in respect of the use of the jetty through wharfage rates or otherwise and may, with the Minister's approval, bind itself by contract so to do.

CONSTITUTION.

No. 33 of 1955.

AN ACT to amend the *Constitution Act 1934*.

[21 October, 1955.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Constitution Act 1955*.

(2) The *Constitution Act 1934*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section twenty-seven of the Principal Act is amended by omitting from subsection (1) the word “Darwin” and substituting therefor the word “Braddon”.

RURAL FIRES.

No. 34 of 1955.

AN ACT to amend the *Rural Fires Act* 1950. [3 November, 1955.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Rural Fires Act* 1955. Short title and citation.

(2) The *Rural Fires Act* 1950, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section forty-five of the Principal Act is amended—

(a) by omitting subsection (4) and substituting therefor the following subsection:—

“(4) No person shall operate, or cause or permit to be operated, a locomotive or traction engine that is operated by solid fuel unless the locomotive or traction engine is equipped with—

(a) such devices for arresting sparks and for preventing the escape of live coals from the ashpan and firebox thereof, and such watering devices and other devices for the prevention of outbreaks of fire;

(b) an ashpan or firebox, or both, of such type; and

(c) such fire-fighting tools and appliances, as may be prescribed, or, in the absence of regulations in that behalf, as the Board may approve.”.

Certain engines, &c., to be fitted with devices for arresting sparks, &c.

3 Section fifty of the Principal Act is repealed and the following section is substituted therefor:—

“50 Nothing in this Act, and no proceeding in respect of an offence against this Act, affects any right or remedy by civil process in respect of damage caused by fire that any
