AN ACT to amend the North-Western Co-operative Freezing and Canning Company's Loan Act 1913, the North-Western Co-operative Freezing and Canning Company's Loan Act 1935, and the North-Western Co-operative Freezing and Canning Company's Loan Act 1937. [24 May, 1944.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:---

**1** This Act may be cited as the North-Western Co-opera- short title. tive Freezing and Canning Company's Loans Act 1944.

 2—(1) The North-Western Co-operative Freezing and Variation of repayment anning Company's Loan Act 1913\* is amended—
 (a) by deleting the words "on or before the thirty- Act of 1913. Canning Company's Loan Act 1913\* is amended-

(b) by deleting the words "four pounds ten shillings" in section six and substituting therefor the words "four pounds".

(2) The Treasurer may, subject to such terms and conditions as he thinks necessary, remit the arrears of interest due on the thirtieth day of June, 1944, in respect of the loan authorised by the North-Western Co-operative Freezing and Canning Company's Loan Act 1913.

(3) Subsection (1) shall commence on the first day of July. 1944.

**3** The North-Western Co-operative Freezing and Canning Company's Loan Act 1935\* is amended by omitting subsections (3), (4), and (5) of section ten, and substituting therefor the following subsection-

"(3) The new loan, together with all interest due thereon and unpaid, shall be repaid by the company to the Treasurer on demand.".

**4**—(1) The North-Western Co-operative Freezing and Canning Company's Loan Act 1937<sup>+</sup> is amended-

- (a) by deleting the words "on the twenty-second day of July, one thousand nine hundred and fortytwo" in section five and substituting therefor the words "on demand";
- (b) by deleting the words "or on the date last aforesaid" in subsection (1) of section six and substituting therefor the words "the twenty-second day of July, 1942"; and
- (c) by omitting subsection (2) of section six and substituting therefor the following subsection-

"(2) Subject to this section, the company shall pay to the Treasurer interest in respect of the said loan at the rate of four pounds per centum per annum in the manner provided by subsection (3).".

(2) Paragraph (c) of subsection (1) shall commence on the first day of July, 1944.

Reduction of capital of company.

5-(1) The North-Western Co-operative Freezing and Canning Company Limited shall be deemed to be authorised by its articles of association to reduce its share capital by special resolution in accordance with the provisions of the Companies Act 1920.<sup>‡</sup>

(2) This section shall be deemed to have come into operation on the first day of May, 1944.
