PORT HUON WHARF.

No. 52 of 1955.

AN ACT to vest the wharf at Shipwright's Point, Port Huon, known as the Port Huon Wharf, in the Marine Board of Hobart, and to provide for matters incidental thereto, and to repeal the Port Huon Wharf Act 1947, the Port Huon Wharf Act 1949, and the Port Huon Wharf Act 1952.

[15 December, 1955.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title, incorporation, and commencement.

- 1—(1) This Act may be cited as the Port Huon Wharf Act 1955.
- (2) This Act is incorporated, and shall be read as one, with the *Marine Act* 1921 (in this Act referred to as the Principal Act).
- (3) This Act shall be deemed to have commenced on the first day of July 1955.

Repeal.

2 The Port Huon Wharf Act 1947, the Port Huon Wharf Act 1949, and the Port Huon Wharf Act 1952 are repealed.

Interpreta-

- 3 In this Act, unless the contrary intention appears—"Board" means the Marine Board of Hobart;
 - "wharf" means the wharf at Shipwright's Point, Port Huon, commonly known as the Port Huon Wharf.

Vesting of wharf in Board. 4 The wharf is, by force of this section, vested in the Board for the purposes of the Principal Act.

Port dues and wharfage rates.

- **5** Notwithstanding anything contained in the Principal Act the Board shall not—
 - (a) fix greater wharfage rates; or

- (b) impose greater quayage and pilotage dues and charges,
- in respect of the wharf and of Port Huon than in respect of wharves in the Port of Hobart and of that port.
- 6 For the purpose of assisting the Board to pay for Subsidy and maintain the wharf a subsidy is payable by the Treasurer to the Board out of the Consolidated Revenue (which, to the necessary extent, is appropriated accordingly) of—
 - (a) in each of the eighteen financial years commencing on the first day of July 1955, the sum of fifteen thousand pounds;
 - (b) in the financial year commencing on the first day of July 1973, the sum of eight thousand pounds: and
 - (c) in respect of the financial year commencing on the first day of July 1974, the sum of two thousand five hundred pounds.

LAUNCESTON CORPORATION.

AN ACT to authorize the payment of certain expenses out of moneys appropriated by the Launceston City Council and to amend the Launceston Corporation Act 1941.
