

## CIRCULAR HEAD MARINE BOARD LOAN.

---

No. 44 of 1952.

AN ACT to amend the *Circular Head Marine Board Loan Act 1950.* [17 October, 1952.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

**1**—(1) This Act may be cited as the *Circular Head Marine Board Loan Act 1952.*

(2) The *Circular Head Marine Board Loan Act 1950*, is in this Act referred to as the Principal Act.

Power to borrow for certain works.

**2** Section three of the Principal Act is amended by omitting therefrom the numerals “£32,000” and substituting therefor the numerals “£60,000”.

Title.

**3** The title of the Principal Act is amended by omitting therefrom the words “sum of money not exceeding £32,000” and substituting therefor the words “certain sum of money”.

## RAILWAY ADVANCES AND SUSPENSE ACCOUNTS (REPEAL).

No. 45 of 1952.

AN ACT to repeal certain enactments relating to the opening and keeping of certain accounts, and the raising and appropriating of certain moneys, for the purposes of the Government Railways. [28 October, 1952.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

**1** This Act may be cited as the *Railway Advances and Suspense Accounts (Repeal) Act 1952.*

**2** The Acts specified in the schedule to this Act are <sup>Repeal.</sup> repealed.

COMMONWEALTH POWERS (AIR TRANSPORT).

No. 46 of 1952.

AN ACT to refer to the Parliament of the Commonwealth the matter of air transport.

[28 October, 1952.]

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as the *Commonwealth Powers (Air Transport) Act 1952.* Short title and commencement.

(2) This Act shall commence on a date to be fixed by proclamation.

**2** The matter of air transport is referred to the Parliament of the Commonwealth for a period commencing on the date on which this Act commences and ending on the date fixed, pursuant to section three, as the date on which this Act shall cease to be in force, but no longer. Reference of matter to the Parliament of the Commonwealth.
