# A BILL

To amend the *Melbourne Corporation (Election of Council) Act* 1982 to enable the holding of a general election and to provide for the fixing of the day in 1985 on which that election is to be held.

BE IT ENACTED by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):

### Short title.

1. This Act may be cited as the Melbourne Corporation (Election of Council) (Amendment) Act 1984.

#### Commencement.

2. This Act shall come into operation on a day to be fixed by proclamation of the Governor in Council published in the *Government Gazette*.

## Principal Act.

**3.** In this Act the *Melbourne Corporation (Election of Council) Act* 1982 is referred to as the Principal Act.

## Election of Council for a further three year term.

- 4. The Principal Act shall be amended as follows:

  (a) In section 2(1) after the interpretation of "Order in County".
  - (a) In section 2 (1) after the interpretation of "Order in Council" there shall be inserted the following interpretation:
    - "Prescribed" means prescribed by regulations made under section 149 of the Local Government Act 1958 and in force before the commencement of the Melbourne Corporation (Election of Council) (Amendment) Act 1984 or by any regulations made under that section after that commencement."
  - (b) In section 3 (2) for the expression "1985" there shall be substituted the expression "1988";
  - (c) In section 24 for the expression "general election of the council in 1985" there shall be substituted the words "next general election":
  - (d) In section 30 (4) for the expression "sum of \$50 which sum" there shall be substituted the words "prescribed deposit which":
  - (e) In section 30 (5) for the expression "sum of \$50" there shall be substituted the words "prescribed deposit";
  - (f) In section 34 for the expression "\$40" there shall be substituted the expression "10 penalty units";
  - (g) In section 35 (2) (a) for the words "the general election" there shall be substituted the words "a general election";
  - (h) In section 41 for the expression "general election of the council in 1985" there shall be substituted the words "holding of a general election of the council";
  - (i) In sections 55 (4), 55 (6) and 56 for the expression "\$200" there shall be substituted the expression "10 penalty units";
  - (j) In section 59 (3) for the expression "\$100" there shall be substituted the expression "10 penalty units";
  - (k) In section 63 (5) for the expression "sum of \$40" there shall be substituted the expression "prescribed sum of money";
  - (1) In section 64 (b) for the expression "and in 1984" there shall be substituted the expression ", 1984, 1986 and 1987";
  - (m) In section 71 (1) (a) for the expression "sum of \$40" there shall be substituted the expression "prescribed deposit"; and
  - (n) Sections 73 (2), 73 (3) and 74 shall be repealed.
