A BILL

to revoke the permanent reservations and Crown grants of certain lands and for other purposes.

Melbourne Lands Act 1987

The Parliament of Victoria enacts as follows:

Purpose.

The purpose of this Act is to revoke the permanent reservations and Crown grants of certain parts of Yarra Park and the Yarra Park
 Primary School Reserve so that those lands can be used in connection with the widening of Punt Road.

Commencement.

2. This Act comes into operation on the day on which it receives the Royal Assent.

10 Revocation of reservations and Crown grants.

- 3. (1) This section applies despite anything to the contrary in the Crown Land (Reserves) Act 1978 or any other Act or law.
- (2) The Minister administering the Conservation, Forests and Lands Act 1987, upon receiving a plan of survey of a portion of the land specified in Column 1 of an item in the Schedule signed by the Surveyor-General and upon being satisfied that the land described in the plan of survey corresponds as nearly as practicable with the land described in Column 3 of that item, may recommend to the Governor in Council

that the Order in Council specified in Column 1 of that item and the Crown grant specified in Column 2 of that item be revoked to the extent that they apply to the land shown in the plan of survey.

- (3) The Governor in Council on the recommendation of the Minister in accordance with sub-section (2), may by Order published in the *Government Gazette* revoke the Order in Council and Crown grant to which the recommendation applies to the extent that they apply to the land shown in the plan of survey.
- (4) An Order under sub-section (3) must include a copy of the plan of survey of the land to which the Order applies.
- (5) If a lease or encumbrance existing immediately before the date of publication in the *Government Gazette* of an Order revoking an Order in Council and Crown grant specified in an item in the Schedule applies to—
 - (a) land in respect of which the Order in Council and Crown grant are revoked by that Order; and
 - (b) land specified in Column 1 of that item, not being land referred to in paragraph (a)—

the lease or encumbrance is, on the date of publication of that Order, deemed to relate only to the land referred to in paragraph (b).

Land deemed to be unalienated land of the Crown.

4. Despite any Act or law to the contrary, land to which an Order under section 3 (3) applies is deemed to be unalienated land of the Crown, freed and discharged from all trusts, limitations, reservations, restrictions, encumbrances, estates and interests.

No compensation payable by Crown except in certain cases.

5. Except as provided in any agreement entered into under section 45 (3) of the *Transport Act* 1983 (whether before on or after the date of commencement of this Act), no compensation is payable by the Crown in respect of anything done under, or arising out of, this Act.
