## A BILL

to repeal the **Victorian Public Offices Corporation Act 1974**, to amend various other Acts and for other purposes.

### **Victorian Public Offices Corporation (Repeal) Act 1990**

The Parliament of Victoria enacts as follows:

#### 1. *Purpose*

5 The purposes of this Act are to repeal the **Victorian Public Offices Corporation Act 1974**, to make consequential amendments to various other Acts and to provide for other related matters.

#### 2. *Commencement*

- 10 (1) Clause 6 is deemed to have come into operation on 11 May 1989.
- (2) The rest of this Act comes into operation on the day on which this Act receives the Royal Assent.

**3. *Repeal of Victorian Public Offices Corporation Act***

The Victorian Public Offices Corporation Act 1974 is repealed.

**4. *Amendments to other Acts***

- (1) In Schedule 4 to the Conservation, Forests and Lands Act 1987, item 70.1 is repealed. 5
- (2) In the Schedule to the Land Acquisition and Compensation Act 1986, the item relating to the Victorian Public Offices Corporation Act 1974 is repealed.
- (3) In Schedule 2 to the Public Account (Trust Funds) Act 1982, the item relating to the Victorian Public Offices Corporation Act 1974 is repealed. 10
- (4) In section 3 of the Historic Buildings Act 1981 (definition of "Public authority"), omit "the Victorian Public Offices Corporation". 15
- (5) In the State Insurance Office Act 1984, section 13 is repealed.

**5. *Abolition of Corporation, Committee and Fund***

- (1) The Victorian Public Offices Corporation and the State Accommodation Committee are dissolved and their members cease to hold office as members of the Corporation or Committee. 20
- (2) The Public Offices Fund established under section 13 of the Victorian Public Offices Corporation Act 1974 is abolished. 25

**6. *Transfer of assets and liabilities***

- 5
- (1) On and from the date of commencement of this section the Victorian Public Offices Corporation (“the Corporation”) must be taken to have been authorised to surrender its assets and rights to the Crown.
  - (2) On and from the date of commencement of this section the Corporation must be taken to have been authorised to transfer its obligations in respect of money borrowed by it to the Victorian Public Authorities Finance Agency.
