

# National Parks (Amendment) Bill 1983

## CLAUSE NOTES

*Cluses* 1, 2 and 3 are the usual citation provisions, allowing for the act to come into operation on the day it receives the royal assent, except for several parts of section 4 which will require proclamation. These are the provisions for five new parks. The Grampians National Park will be established from 1 July 1984.

*Clause* 4 itemises in thirteen sub-sections the amendments to schedule 2 and 3 of the Principal Act made by this act. *Subclauses* relating to proclamation of specific parks are (3) Grampians

- (4) Kara Kara
- (5) Kooyoora
- (6) Langi Ghiran
- (7) Moondarra
- (8) Tyers
- (9) Moondarra—substituted area excluding S.E.C. proposal for Anderson Creek Overburden Dump.

*Sub-clauses* (10) and (11) relate to land being excluded from parks. Details are given in the notes to the schedules.

*Sub-clauses* (12) and (13) are the usual machinery clauses, to close certain unused roads in parkland, and to excise areas of reserved forest included in the new parks.

*Clause* 5 amends section 19 (4) of the Principal Act, a transitional provision with respect to purchased land, applying the section to land where possession has been taken pending finalization of a contract, and making it clear that the provision applies to land purchased for any conservation purpose.

*Clause* 6 adds a new paragraph in section 21A of the National Parks Act. This provision is parallel to section 62 (1A) of the Forests Act, which is changed by Clause 15. The effect is that land subject to section 19C of the National Parks Act becomes protected public land for the purposes of the Forests Act.

*Clause* 7 includes the Cape Otway Public cemetery, an historic cemetery, now closed to public burials, as one of which the Director is sole trustee under Section 32 of the Act, notwithstanding the provisions of the Cemeteries Act 1958 requiring a minimum of three trustees.

*Clause* 8 amends and updates section 32D of the Principal Act with respect to areas contained in parks in Schedules Two and Three where the Director may authorize fossicking, substituting new sub-sections relating to persons, due notice and conditions. The parks concerned are:

The effect of the changes is to allow general as distinct from specific authorities e.g., for club excursions.

Clause 9 inserts section 41A in the Principal Act, providing that land included in a park is no longer reserved or affected by proclamation or Order under the *Land Act 1958* or the *Crown Land (Reserves) Act 1978*. This is an updated version of former section 53, which is repealed by clause 13.

Clause 10 provides for increased penalties and for putting penalties in penalty units. A summary of details is as follows:

Clause 11 amends section 47 of the Principal Act, widening the scope of certificates to be issued by the Director.

Clause 12 introduces two new sections into the Principal Act.

- *Proposed Section 47B* is a general penalty provision.
- *Proposed Section 47C* provides for expiation of an offence by payment of a fee.

Clause 13 repeals Part VII of the Principal Act—The Transitional Provisions and Consequential Amendments provided for in 1975, which have been put into effect and are no longer required. One provision, section 53, re-written, is to become section 41A.

Clause 14 validates the surrender of certain land at Warrandyte to the Crown by the M.M.B.W., in exchange for the Board being given control of Westerfolds Park. The Auditor-General had subsequently questioned the power of the Board to surrender this land.

Clause 15 makes a consequential amendment to section 62 (1A) of the Forests Act, providing for land managed by the Director under section 19C of the National Parks Act to be deemed to be protected public land.

Clause 16 provides for an amendment to the area of the Mt. Hotham Alpine Reserve following exclusion of an area to be included in Bogong National Park.

## SCHEDULE

### Part A—Amends Schedule Two to the Principal Act.

*Item (h)—Proposed new part 34—Grampians National Park.* To be declared in pursuance of Recommendations A1, M2, M3, C3, C5 and C6 of the Land Conservation Council for the South Western Area, District 2, May 1982.

*Area* 1670 km<sup>2</sup> (167 000 hectares).

#### *Details of Significance*

1. Timber harvesting will be allowed for three years in the red gum areas, and for 10 years in other areas where the land Conservation Council has recommended timber harvesting.

2. The Brady Swamp area east of the wannon River will be left out of the Grampians National Park at the initial stage. This area will be managed by the National Parks Service while Government agencies study the future of duck shooting

over the swamp. The relative location of public and private land and the indefinite nature of property boundaries in this locality make enforcement of any ban on hunting very difficult.

3. Areas have been excluded to protect water storages.

4. Stone from the Heatherlie Quarry will continue to be available for repairs to historic buildings.

5. Apiculture will be permitted to continue.

6. Occupancies in the Grampians are to continue for the time being. They will be reviewed when the National Parks service draws up a management plan.

7. Arrangements will be made for fire lookouts, helipads, airstrip, fire protection installations and communications installations to continue in accordance with recommendations of the Land Conservation Council.

8. The Government is studying management planning possibilities for the area, as well as the provision of a park headquarters and information centre.

9. Tourist roads and other roads maintained by the R.C.A. will be excised from the park at this stage. Other roads will not be excised, but administrative arrangements for maintenance will be continuing.
