

## EDWARDI SEPTIMI REGIS.

No. 1814.

An Act relating to certain Land granted as a Site for a Market Place in the City of Ballaarat.

[5th February, 1903.]

HEREAS by a Deed Poll bearing date the eighteenth day of Preamble. August One thousand eight hundred and eighty-two under the hand of His Excellency the Marquis of Normanby Governor and Commander in-Chief in and over the Colony of Victoria and its dependencies with the seal of the said colony affixed Her Majesty in order to provide a site for a market place in the City of Ballaarat did grant unto the Mayor Councillors and Citizens of the said city and to their successors all that piece of land in the said deed mentioned, subject to certain Register Book, conditions, provisions, and declarations therein mentioned, and amongst others that the land so granted should at all times thereafter be maintained and used for a site for a market place for the purpose of holding markets and offices and conveniences connected therewith and for no other purpose whatsoever: And whereas of the land so granted the portion described in the Schedule to this Act is not leased to any person schedule. under the provisions of the Act No. 937 and is not used for or applied to or required for the purpose for which the same was granted: And whereas the Council of the City of Ballaarat desire that the said portion of the land so granted should be revested in His Majesty and set apart for the purpose of a court house and offices and conveniences connected therewith being constructed, maintained, and used on the said portion: And whereas it is expedient that such portion should be so revested and set apart for the purpose aforesaid: Be it therefore enacted by the King's Most Excellent Majesty

Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

Short title.

1. This Act may be cited as the Ballaarat Court House Land Act 1902.

Crown grant in part revoked.
Schedule.

2. So far only as relates to the land described in the Schedule to this Act the Crown grant bearing date the eighteenth day of August One thousand eight hundred and eighty-two by which certain land in the said City of Ballaarat was granted to the Mayor Councillors and Citizens of the said City and to their successors as a site for a market place for holding markets and offices and conveniences connected therewith is hereby made void revoked and annulled, and the Registrar of Titles is hereby directed to cancel to the necessary extent the enrolment of record thereof in the Office of Titles, and the said land is hereby revested in His Majesty freed and discharged from the trusts limitations and restrictions set forth in the said Crown grant.

Land described in Schedule set apart for court house site. 3. The land described in the Schedule to this Act and revested in His Majesty as aforesaid shall without further or other authority than this Act be set apart and used as a site for a court house and offices and conveniences connected therewith and for no other purpose whatsoever.

## SCHEDULE.

DESCRIPTION OF LAND TO BE REVESTED IN HIS MAJESTY AS A SITE FOR A COURT HOUSE IN THE CITY OF BALLAARAT.

Thirty-seven perches and seven-tenths of a perch being portion of the land situate in section C, city of Ballarat, parish of Ballarat, county of Grenville, reserved from sale permanently as a site for Market purposes pursuant to Order in Council dated the four-teenth August, 1882, and published in the Government Gazette of the eighteenth August, 1882, page 2020, and more particularly described in the Crown grant entered in the Register Book, vol. 1411, folio 282095, namely:—

Commencing at a point bearing north thirty-six degrees forty-seven minutes east four chains twenty-three links and two-tenths of a link from the intersection of the north side of Sturt-street with the west side of Camp-street; bounded thence by Camp-street bearing north thirty-six degrees forty-seven minutes east forty-one links and eight-tenths of a link and north twenty-seven degrees forty-one minutes west ninety-nine links to the south-east angle of the reserve for Police purposes; thence by the south boundary of that reserve bearing west two chains nineteen links and one-half link; and thence by lines bearing respectively south sixty links and six-tenths of a link, east eighteen links and two-tenths of a link, south fifteen links and two-tenths of a link, and south seventy-eight degrees twenty-eight minutes east two chains twenty-six links and eight-tenths of a link to the point of commencement.
