An Act to revoke the Proclamation as a Public Road of certain Land in the Town of Benalla and to vest such Land in the Country Fire Brigades Board.

[6th April, 1903.]

TTHEREAS by a Proclamation dated the twenty-third day of Preamble. December One thousand eight hundred and seventy-four under Government Gazetts, the hand of His Excellency the Governor certain lands within the Shire of Benalla were proclaimed to be public roads under the provisions of the Shires Statute (33 Vict. No. 358) : And whereas of the land so proclaimed the portion described in the Schedule to this Schedule. Act is not required for the purposes of a public road : And whereas the Council of the Town of Benalla desires that the land described in the said Schedule be vested in the Country Fire Brigades Board for the purposes of a Fire Brigade station and offices and conveniences connected therewith : Be it therefore enacted by the King's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

Revocation in part of proclamation and vesting of land. Schedule.

2. So far as relates to the land described in the Schedule to this Act the Proclamation bearing date the twenty-third day of December One thousand eight hundred and seventy-four by which certain lands in the Shire of Benalla were proclaimed to be public roads is hereby revoked and the land described in the said Schedule shall without further or other authority than this Act be vested in the Country Fire Brigades Board for the purposes of the *Fire Brigades Act* 1890 and any Act amending the same.

SCHEDULE.

Portion of a road proclaimed on the twenty-third December, One thousand eight hundred and seventy-four, under the Shires Statute (33 Vict. No. 358), section Three hundred and seventy-six, as a public road, under the designation of Nunn-street, vide Government Gazette of thirty-first December, One thousand eight hundred and seventy-four, page 2298.

Five and a half perches, county of Delatite, parish of Benalla, town of Benalla: Commencing at a point bearing S. twenty-six degrees E. one hundred and fifty-nine feet and S. sixty-four degrees W. thirty-three feet from the west angle of allotment 1 of section X; bounded thence by lines bearing respectively S. twenty-six degrees E. forty-five feet, S. sixty-four degrees W. thirty-three feet, N. twenty-six degrees W. forty-five feet, and N. sixty-four degrees E. thirty-three feet to the point of commencement.
