An Act to amend the *Cattle Compensation Act 1967* and the *Swine Compensation Act 1967* with respect to the further use of Moneys standing to the credit of the Cattle Compensation Fund and the Swine Compensation Fund, to amend the *Stamps Act 1958* and for other purposes.

[17th April, 1973.]

BE it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

1. This Act may be cited as the *Cattle Compensation Act 1973*.

Short title.

2. After sub-section (3) of section 10 of the *Cattle Compensation Act 1967* there shall be inserted the following sub-sections :—

'(3A) In addition to any amount which may be applied out of the Fund under sub-section (3) a further amount not exceeding half of the net amount standing to the credit of the Fund on the day on which the *Cattle Compensation Act 1973* receives the Royal Assent may be applied from the Fund for the purpose of paragraph (c) of sub-section (3).

(3B) For the purposes of sub-section (3A) "net amount" means the amount standing to the credit of the Fund less any unspent amount which has been authorized to be applied for the purpose of paragraph (c) of sub-section (3).'

3. After sub-section (3) of section 10 of the *Swine Compensation Act 1967* there shall be inserted the following sub-sections :—

'(3A) In addition to any amount which may be applied out of the Fund under sub-section (3) a further amount not exceeding half of the net amount standing to the credit of the Fund on the day on which the *Cattle Compensation Act 1973* receives the Royal Assent may be applied from the Fund for the purpose of paragraph (c) of sub-section (3).

(3B) For the purposes of sub-section (3A) "net amount" means the amount standing to the credit of the Fund less any unspent amount which has been authorized to be applied for the purposes of paragraphs (c) and (d) of sub-section (3).'

Amendment of
Third Schedule.

4. In clause XVIII. of the Third Schedule to the *Stamps Act 1958*—

- (a) for the expression "Four Cents (\$0.04)" there shall be substituted the expression "Two Cents (\$0.02)";
- (b) for the expression "Thirty-two cents (\$0.32)" there shall be substituted the expression "Sixteen Cents (\$0.16)".
