An Act to provide for the Renewal of a certain Victualler's Licence in pursuance of a Certificate granted by the Licensing Court for the Licensing District of Swan Hill.

[1st October, 1924.]

Preamble.

WHEREAS the licensing court for the licensing district of Swan Hill at a sitting held at Melbourne on the seventeenth day of December One thousand nine hundred and twenty-three granted to Elsie Merle Franklin of Hopetoun a certificate authorizing the renewal of the victualler's licence in respect of the premises known as the Club Hotel, Hopetoun: And whereas the said licence was not renewed: And whereas it is expedient to authorize the renewal of the said licence for the remainder of the year One thousand nine hundred and twenty-four as hereinafter provided: Be it therefore enacted by the King's Most Excellent Majesty by and with the advice

and

and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

1. This Act may be cited as the Club Hotel, Short title and construction. Hopetoun, Licence Act 1924 and shall be read and construed Nos. 2688 &c. as one with the Licensing Acts.

Power to receive fee for Club

- 2. Notwithstanding anything in the Licensing Acts—
- (1) It shall be lawful for the Treasurer or receiver of Hotel, Hopetoun, and to issue licence therefor. Act to receive and pay into The Licensing Fund the sum of One hundred and twenty-one pounds and six pence being the fee payable under the Licensing Acts for the year One thousand nine hundred and twenty-four in respect of the premises known as the Club Hotel, Hopetoun; but the said sum shall not be so received unless the applicant also pays to the said Treasurer or receiver of revenue a further sum by way of fine of ten per centum of such sum;
- (2) Forthwith after such sums have been received by the Treasurer or receiver of revenue the said Elsie Merle Franklin may obtain the renewal of the victualler's licence for the said premises for the remainder of the year One thousand nine hundred and twenty-four or the owner or mortgagee of the licensed premises not being the occupier thereof may within one week after the expiration of the said period of ten days obtain for the remainder of the year One thousand nine hundred and twenty-four the renewal of the said licence in manner provided by sections one hundred No. 2883
 88. 104, 105. and four and one hundred and five of the Licensing Act 1915 as amended by any Act so far as the said sections are applicable; and

(3) For the purposes only of this section and of the 1b. said sections one hundred and four and one hundred and five as amended by any Act the certificate granted to the said Elsie Merle Franklin by the licensing court for the licensing district of Swan Hill at a sitting held at Melbourne on the seventeenth day of December One thousand nine hundred and twenty-three authorizing the renewal of the said licence shall be deemed to be of full force and effect.
