An Act to amend the Dog Acts.

[6th November, 1957.]

BE it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :---

1. This Act may be cited as the Dog Act 1957 and shall short title be read and construed as one with the Dog Act 1928 and citation. (hereinafter called the Principal Act) and the Acts amending 4685, 4856. the same all of which Acts and this Act may be cited together as the Dog Acts.

2. (1) The Principal Act as amended by any Act is Amendment of No. 3667. hereby amended as follows :---

(a) In section five for the words "Five shillings" there shall be substituted the expression "such and other fees and charges. amount, being not less than Five shillings and Registration fee. not more than Ten shillings, as is fixed by by-law of the council of the municipality";

(2) The provisions of the Local Government Acts relating to the making of by-laws under sub-section (1) of section one hundred and ninety-seven of the Local Government Act 1946 and to such by-laws when made shall extend and apply to the making of by-laws for the purposes of the Dog Acts and to such by-laws when made.

3. (1) The Principal Act as amended by any Act is hereby amended as follows :--

- (a) In section eight for the words "not less than Ten shillings nor more than Forty shillings" there shall be substituted the words "not less than One pound and not more than Five pounds";
- (b) In section ten for the words "Ten shillings" there shall be substituted the words "One pound";
- (c) In section seventeen—
 - (i) for the words "not less than Five nor more than Forty shillings" there shall be substituted the words "not less than Ten shillings and not more than Five pounds"; and
 - (ii) for the words "not less than Ten shillings nor more than Five pounds" there shall be substituted the words "not less than One pound and not more than Ten pounds";
