An Act to further amend Part IV. of the
Financial Emergency Act 1931.

[29th November, 1937.]

BE it enacted by the King's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

1. (1) This Act may be cited as the *Financial Emergency (Grants and Funds) Act 1937* and shall be read and construed as one with Part IV. of the *Financial Emergency Act 1931* (hereinafter called the Principal Act) and any Act amending the same all of which Acts and this Act may be cited together as the Financial Emergency Acts.
