An Act to sanction the Issue and Application of Loan Money for Public Works and other Purposes.

[13th December, 1960.]

**B**E it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

1. This Act may be cited as the *Public Works Loan Application Act 1960.* Short title.

2. From the Loan Fund there may be issued and applied the several amounts specified in the Schedule to this Act for the respective works and purposes specified opposite thereto, not exceeding Eighteen million six hundred and fourteen thousand eight hundred and sixty-one pounds in all.
