## EDWARDI SEPTIMI REGIS.

No. 1839.

An Act to revoke the permanent reservation and grant of certain land at St. Arnaud.

[6th April, 1903.]

THEREAS by an Order in Council dated the fifteenth day of Preamble. October One thousand eight hundred and sixty the Governor in Council did set apart a portion of the land described in the Schedule to this Act as a site for a combined denominational school: And whereas by a further Order in Council dated the twenty-ninth day of July One thousand eight hundred and sixty-two the remaining portion of the land described in the said Schedule was reserved from sale permanently as a site for a combined denominational school: And whereas by a deed-poll bearing date the twenty-second day of March One thousand eight hundred and sixty-five and registered in the register-book of the Office of Titles volume one hundred and twenty-nine folio twenty-five thousand seven hundred and twelve the Governor in Council did grant unto Charles Henry Raven Charles Ferris Lewis William Clow George Powell and John McHale all of St. Arnaud the whole of the land described in the said Schedule as a site for a combined denominational school: And whereas the land so set apart and the land so permanently reserved and granted is not required for the purpose aforesaid and it is expedient for His Majesty to resume possession of the same: Be it therefore enacted by the King's Most Excellent Majesty

by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

Short title.

1. This Act may be cited as the St. Arnaud Land Act 1903.

Revocation of Order in Council,

Schedule.

2. (1) The Order in Council bearing date the fifteenth day of October One thousand eight hundred and sixty by which a portion of the land described in the Schedule to this Act was set apart as a site for a combined denominational school is hereby revoked.

Schedule.

(2) The Order in Council bearing date the twenty-ninth day of July One thousand eight hundred and sixty-two by which the remaining portion of the land described in the said Schedule was reserved from sale permanently as a site for a combined denominational school is hereby revoked.

Revocation of grant and revesting of land in Ilis Majesty. 3. The Crown grant bearing date the twenty-second day of March of One thousand eight hundred and sixty-five of the land described in the said Schedule is hereby made void revoked and annulled and the Registrar of Titles is hereby authorized and directed to cancel the enrolment of record thereof in the Office of Titles; and the said land is hereby revested in His Majesty freed and discharged from all trusts limitations and restrictions whatsoever and shall be deemed to be and may be dealt with as unoccupied Crown land.

## SCHEDULE.

Two acres, county of Kara Kara, parish of St. Arnaud, town of St. Arnaud, being allotments two and three of section M: Commencing at the western angle of allotment three; bounded on the north-west by allotment one bearing N. 49° 13′ E. five chains; on the north-east by McMahon-street bearing S. 40° 47′ E. four chains; on the southeast by allotment five bearing S. 49° 13′ W. five chains; and on the south-west by Changarnier-street bearing N. 40° 47′ W. four chains to the point of commencement.
