### An Act to revise the Statute Law.

[14th December, 1965.]

QE it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):-

- 1. This Act may be cited as the Statute Law Revision Act short title. 1965.
- 2. The Acts mentioned in the First Schedule to this Act to Acts to be the extent to which they are in and by that Schedule expressed repealed. to be amended or repealed are hereby amended or repealed First Schedule. accordingly.

- 3. This Act shall, to the extent that it amends or repeals by reference to the First Schedule to this Act the Public Lands and Works Act 1964, be deemed to have come into operation on the 15th day of March, 1965, and to the extent that it amends by reference to item 71 of the First Schedule to this Act the Local Government Act 1958, be deemed to have come into operation on the 1st day of March, 1963.
- 4. The Acts mentioned in the Second Schedule to this Act Acts spent in to the extent to which they are in and by that Schedule expressed be repealed. to be repealed are hereby repealed accordingly.
