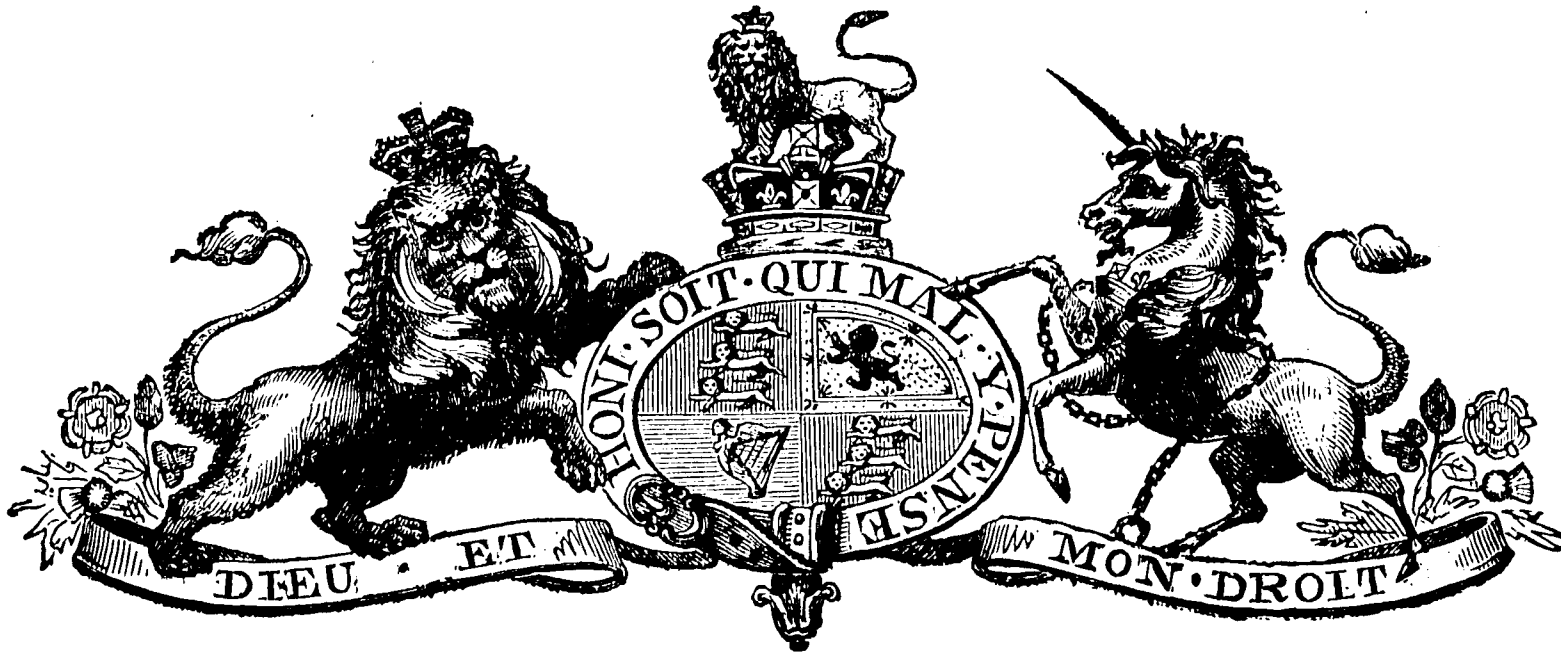

No. 1340.

An Act to sanction the issue and application of certain sums of money as Loans for Water Supply and Irrigation Works in the Country Districts and for other purposes.

[6th November, 1893.]

BE it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

1. This Act may be cited as the *Water Supply Loans Application Act* 1893 (No. 2). Short title.

2. Pursuant to the provisions of Part II. of the *Water Act* 1890 the Governor in Council may grant as a loan to each Waterworks Trust named in the First Part of the Schedule to this Act any sum or sums not exceeding the amount set forth in the said Part opposite to the name of such Trust. 3. (1) The sums specified in the Second Part of the Schedule to this Act may be respectively expended for the purposes therein mentioned.

(2) The works specified in the Second Part of the Schedule to this Act are hereby declared to be National works within the meaning of Part III. of the *Water Act* 1890.

4. The Treasurer of Victoria is hereby authorized to issue any sums set out in the Schedule to this Act not exceeding in the whole Thirty thousand and six hundred pounds from that portion of "The Victorian Stock Act 1891 Account" appropriated "for irrigation works and water supply in country districts to be expended in such manner as Parliament shall direct" or from such portion of any other Loan Account to be provided by Parliament as may be appropriated for the like purpose.
