An Act relating to certain Crown Lands situate within the Walpeup West Waterworks District and certain Improvements thereon.

[21st September, 1927.]

THEREAS the lands described in the Schedule to this Preamble. Act are unalienated lands of the Crown situate within the Walpeup West Waterworks District (which was constituted pursuant to the Water Acts a waterworks district by Order in Council of the twenty-third day of See Government December One thousand nine hundred and twelve): And January, 1913, whereas in on or upon the said lands there are bores with windmills tanks troughs fittings and other movable improvements: And whereas the said bores were constructed prior to the constitution of the said waterworks district for general use but are no longer required for general use: And whereas it is expedient to authorize the leasing or reservation as hereinafter enacted of the said lands and the sale of the improvements thereon and the application of the net proceeds of any such sale in the manner hereinafter provided: Be it therefore enacted by the

the King's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

Short title.

1. This Act may be cited as the Walpeup West Lands Act 1927.

Power to lease land to adjoining lessees.
Comp. No. 3302 5. 4.
Schedule.

- 2. (1) Notwithstanding anything in the Land Acts but subject to this Act the Governor in Council in any case where land adjoining any land described in the Schedule to this Act is held under a selection purchase lease or an agricultural allotment lease may upon the application of the lessee of such adjoining land authorize any adjoining portion of any land described in the said Schedule to be added to the area of the existing lease of such lessee and (subject to such terms and conditions as the Governor in Council thinks fit)—
 - (i) the rent or other payment for or in respect of such added area (which shall be deemed to have the same classification as the adjoining land of the applicant) shall be determined in accordance with such classification; and

(ii) the rent or other payment under the existing or a substituted lease shall be adjusted for each

succeeding half-year accordingly.

(2) Before the Governor in Council authorizes an addition to the area of any existing lease as aforesaid the lessee shall pay to The Board of Land and Works the value as fixed by the said Board of any bore in or upon any land to be added to the area of the lease as aforesaid.

Power to reserve portion of land described in Schedule.

3. In any case where land adjoining any land described in the Schedule to this Act has been reserved from sale under the provisions of the Land Acts for any purpose the Governor in Council may in accordance with the Land Acts reserve for the like purpose such adjoining land described in the said Schedule.

Power to sell windmills &c. and other improvements. Schedule.

- 4. (1) Any windmills tanks troughs fittings and movable improvements in on or upon any of the lands described in the Schedule to this Act—
 - (a) shall for the purposes of this Act be deemed and taken not to have been included in the said lands; and
 - (*b*) may

- (b) may be sold by The Board of Land and Works at a value to be fixed by the said Board and in such manner and subject to such terms and conditions as the said Board determines.
- (2) The net proceeds of any such sale and any amounts Application of paid by lessees in respect of any bores as aforesaid shall be sale. applied towards the reduction of any capital amount standing to the debit of the hereinbefore recited waterworks district in the books of accounts of the State Rivers and Water Supply Commission.

- (g) Two roods: Commencing at a point bearing N. 0° 46' E. fifty-eight chains fifty-seven links from the south-east angle of allotment 48; bounded thence by a line bearing N. 44° 39' W. four chains forty-four links; and thence by roads bearing N. 89° 56½' E. three chains sixteen links, and S. 0° 46' W. three chains sixteen links to the commencing point.

8. Land in the parish of Pallarang.
