Version No. 001 Land (IOOF) Act 1990

The Parliament of Victoria enacts as follows:

Preamble

Certain land at Melbourne was permanently reserved and granted to trustees for use as a site for an Asylum and Hall in connection with the Society known as the Independent Order of Oddfellows of Victoria and that reservation and grant were later altered so that the reference to an Asylum was deleted:

That land is no longer used for that purpose and it is desirable to revoke the reservation and Crown grant so that the land may be sold or leased for other purposes:

The Parliament of Victoria therefore enacts as follows:

1. Purposes

The purposes of this Act are—

- (a) to revoke the permanent reservation and Crown grant of land at Melbourne; and
- (b) to repeal the **Oddfellows Hall (Melbourne) Land Act 1930**.

2. Commencement

This Act comes into operation on a day to be proclaimed.

3. Revocation of reservation and Crown grant

The Order in Council and Crown Grant specified in the Schedule are **revoked**.

4. Land deemed to be unalienated Crown land

- (1) Despite any Act or law to the contrary, the land described in the Schedule is deemed to be unalienated land of the Crown freed and discharged from all trusts, limitations, reservations, restrictions, encumbrances, estates and interests.
- (2) The persons who are for the time being the grantees of the land in the Crown grant specified in the Schedule are discharged from any liability under any trust on which they held the land.

5. Repeal of Oddfellows Hall (Melbourne) Land Act The Oddfellows Hall (Melbourne) Land Act 1930 is repealed.

6. No compensation payable by Crown

No compensation is payable by the Crown in respect of anything done under or arising out of this Act.

7. Amendment of Register Book

The Registrar of Titles, on being requested to do so and on production of any relevant duplicate Crown grant or other document, must make any amendments to the Register Book under the **Transfer of Land Act 1958** and to any duplicate Crown grant, duplicate certificate of title, duplicate registered instrument or other document that are necessary because of the operation of this Act.
