# **The Application**

Big Barrel Enterprises Limited applies for a renewal of the OFF Licence in respect of premises situated at 34 Constable Street, Wellington known as "Big Barrel Newtown." The applicant has operated these premises for about 18 months.

On 29 May 2013, Big Barrel Enterprises Limited, trading as "Big Barrel Newtown", was issued an Off-Licence 049/OFF/21/2013 with the trading hours of Monday to Sunday 8.00 am to 11.00 pm. No changes are sought.

The application was notified in the Wellingtonian on 22 & 29 May 2014. A notice was placed at the principal entrance. No objections were received from members of the public.

The Inspector has reported on the first 12 months of operation and advises that there has been one CPO conducted on the premises and no sale was made to the minor.

During peak times there are always at least two staff members on duty. There are six CCTV cameras covering the interior of the premises with a further three being positioned in the outdoor area covering the car park and pathway leading to/from the Bottle Store and the Tayern.

A small TV screen is located on the bar counter that allows staff to monitor all the positions covered by the CCTV cameras.

Free drinking water is available to customers when complimentary samples of alcohol are being offered on the premises.

### **REASONS FOR THE DECISION**

The inspector reports that the amenity and good order of the area has not been adversely affected and that the applicant has sound host responsibility practices.

Neither the Police nor the Medical Officer of Health has raised any matters in opposition.

Overall I am satisfied as to the matters to which we must have regard as set out in s.105, s.106 and s.131 of the Act.

### **DECISION**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by Big Barrel Enterprises Limited for the renewal of the OFF Licence in respect of premises situated at 34 Constable Street, Wellington known as "Big Barrel Newtown" subject to conditions.

#### **Conditions:**

The licence is subject to the conditions listed below:

 Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

# Monday to Sunday 8am to 11pm;

- The whole of the premises is designated as a Supervised Area;
- Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
- No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day;

- A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- The Licensee must display:
  - At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - ➤ At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale or alcohol;
  - A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

The renewal will be for three years from the first granting of the licence and a replacement licence is to be issued.
