DECISION

This is an application by Robert George Thompson & Anne Mary Thompson (trading in partnership) for renewal of on and off-licences in respect of premises situated at Main Road North, Clareville, Carterton District, known as "Taratahi Hotel".

In addition to the renewal of the on and off-licences the applicant also seeks to reduce the presently authorised trading hours to provide for a closing hour of 2.00 am. This is sought following consultation with the Police who seek to bring the operating hours for the hotel into line with other licensed premises in the Carterton district.

The applications were duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matters on the papers.

We are satisfied as to the matters to which we must have regard as set out in ss.22 and 45 of the Act. We renew the licences until 8 May 2002, that being the anniversary date of the licences and three years from the last renewal, and authorise the issue of replacement licences and renewal certificates.

Sections 7 and 114, Sale of Liquor Act 1989

PURSUANT to the Sale of Liquor Act 1989, the partnership of ROBERT GEORGE THOMPSON & ANNE MARY THOMPSON ("the licensee") is authorised to sell and supply liquor on the premises situated at Main Road North, Clareville, Carterton District and known as "Taratahi Hotel", for consumption on the premises to:

Any person who is for the time being living on the premises, whether as a lodger or an employee of the licensee, or otherwise; or

Any person who is present on the premises for the purpose of dining; or (b)

- Any person who is present on the premises for the purpose of attending any function or entertainment (whether (c) live or not); or
- Any other person who is present on the premises, (d)

and to allow the consumption of liquor on the premises by any such person.

The authority conferred by this licence shall be exercised by the licensee (if an individual) or through a manager or managers appointed by the licensee in accordance with Part VI of the Act.

CONDITIONS

This licence is subject to the following conditions:

- The licensee shall have available for consumption on the premises, at all times when the premises are open for the sale of liquor, a reasonable range of non-alcoholic refreshments:
- No liquor is to be sold or supplied on a Sunday after 2.00 am; or Good Friday; or Christmas Day to any person other than (b) persons who are:
 - For the time being living on the premises whether as a lodger or an employee of the licensee or otherwise; or (i)
 - Present on the premises for the purpose of dining (ii)
- Liquor may be sold only on the following days and during the following hours: (c)
 - At any time on any day to any person who is for the time being living on the premises whether as a lodger or an employee of the licensee, or otherwise.
 - Sunday, Good Friday and Christmas Day 9.00 am to 1.00 am the following day to any person who is present on the (ii) premises for the purpose of dining.
 - Monday to Saturday 7.00 am to 2.00 am the following day (7.00 am to 12.00 midnight on Christmas Eve and on the (iii) Thursday before Good Friday) to any person who is present on the premises for the purpose of attending any function or entertainment (whether live or not).
 - Monday to Saturday 7.00 am to 2.00 am the following day (7.00 am to 12.00 midnight on Christmas Eve and on the (iv) Thursday before Good Friday) to any person who is present on the premises.
- Food shall be available for consumption on the premises as follows:
 - At all times when the premises are authorised to be open for the sale of liquor, food of a range and style similar to that shown on any menu submitted or a range of snack foods in the nature of pies, sandwiches, filled rolls, pizzas and the like, shall be conveniently available for all patrons and the availability of those foodstuffs shall be notified to them by appropriate notices throughout the premises.
- Each of the following parts of the premises is designated as a supervised area: Every bar. (e)
- The licensee shall ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are (f) observed and shall:
 - Display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the sale and supply of liquor to minors and the complete prohibition on sales to intoxicated persons; and
 - Have available for vendor staff forms of the kind anticipated by s.172 of the Act, enabling such staff to require customers to declare in writing that they are of the required age.

In terms of Regulation 7 of the Sale of Liquor Regulations 1990 the sale, supply or consumption of liquor is authorised in the premises generally. The premises located at Main Road North, Clareville, Carterton District are more precisely identified as outlined in a plan date stamped as received by Tribunals Division on 22 August 1991.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence shall be displayed at the principal entrance to the premises. The entrance from Main Road North is designated as the principal entrance.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence shall continue in force -

- Until the close of the period of 1 year commencing with the date of its issue; or (a)
- If an application for the renewal of the licence is duly made, until the application is determined; or (b)
- If the licence is renewed, until the close of the period for which it is renewed. (c)

- (d) The licensee shall ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and shall:
 - (i) Display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the sale and supply of liquor to minors and the complete prohibition on sales to intoxicated persons; and
 - (ii) Have available for vendor staff forms of the kind anticipated by s.172 of the Act, enabling such staff to require customers to declare in writing that they are of the required age.
