### DECISION

Public notification of the application did not attract any objections or notices of desire to be heard. We deal with the matter on the papers.


We are satisfied as to the matters to which we must have regard, and we grant the applicant an on-licence endorsed in terms of s.28. A copy of the licence setting out the conditions to which it is subject is attached to this decision.

The licence may issue immediately.

The applicant's attention is drawn to s.25 of the Act obliging the holder of an onlicence to display:-

A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance.

ON-LICENCE (For Premises) Sections 7 and 114, Sale of Liquor Act 1989

Section 28 applies to this licence.

PURSUANT to the Sale of Liquor Act 1989, STANLEY KWONG-MAN YIP is authorised:

- (a) To allow the consumption of liquor in the restaurant situated at 44 Ridgway Street, Wanganui and known as "Hong Kong Restaurant" by any person who is there for the purpose of dining, if the liquor is brought to the restaurant b that person or any other person dining with that person; and
- (b) To sell and supply any food or hot beverage of which liquor is an ingredient for consumption in the restaurant by an person who is there for the purpose of dining, if the food or beverage supplied to that person contains not more than 14.33 percent alcohol by volume.

Except as stated in paragraph (b) above, this licence does NOT authorise the licensee to sell or supply liquor to any person.

### **CONDITIONS**

This licence is subject to the following conditions:

- (a) The licensee shall have available for consumption on the premises at all times when the premises are open for the sale of food or hot beverages in which liquor is an ingredient, a reasonable range of non-alcoholic refreshments.
- (b) Liquor may be consumed on the premises by persons present for the purpose of dining only on the following days and during the following hours:
  - Monday to Sunday 11.00 am to 11.00 pm
- (c) The licensee shall have available for consumption on the premises at all times when the premises are open food of a similar standard to that described in the menu lodged with the application for a licence.

#### THE LICENSED PREMISES

In terms of Regulation 7 of the Sale of Liquor Regulations 1990 the consumption of liquor is authorised in the premises generally excluding the takeaway area. The premises located at 44 Ridgway Street, Wanganui are more precisely identified as outlined in a plan date stamped as received by the Liquor Licensing Authority on 22 September 1999.

#### DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence shall be displayed at the principal entrance to the premises. The entrance from Ridgway Street is designated as the principal entrance.

#### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence shall continue in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
