DECISION

Public notification of the applications did not attract any objections or notices of desire to be heard. We deal with the matters on the papers.

The general nature of the business to be undertaken is that of a tavern.

Previously Albert Motor Lodge Limited operated the entire complex as a hotel with an on and off-licence covering the whole premises. However, the operation has now been split into three separate premises to be operated by three separate entities. Accordingly separate licences are now sought for the tavern, bottlestore and hotel.

We are satisfied as to the matters to which we must have regard as set out in ss.13 and 35 of the Act, and we grant the applicant the on and off-licences sought. Copies of the licences setting out the conditions to which each is subject are attached to this decision.

The licences may issue immediately.

The applicant's attention is drawn to ss.25 and 48 of the Act obliging the holder of on and off-licences to display:-

- 1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of liquor <u>AND</u>
- 2. A copy of each licence, and of the conditions of each licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance.

ON-LICENCE

Sections 7 and 114, Sale of Liquor Act 1989

PURSUANT to the Sale of Liquor Act 1989, <u>ALPHA TRADING LIMITED</u> is authorised to sell and supply liquor on the premises situated at the corner of Main Street and Albert Street, Palmerston North and known as "Albert Tavern", for consumption on the premises to **any person who is present on the premises** and to allow the consumption of liquor of the premises by any such person.

The authority conferred by this licence shall be exercised by the licensee (if an individual) or through a manager or managers appointed by the licensee in accordance with Part VI of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) The licensee shall have available for consumption on the premises, at all times when the premises are open for th sale of liquor, a reasonable range of non-alcoholic refreshments.
- (b) No liquor is to be sold or supplied on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on ANZAC Day to any person other than persons who are present on the premises for the purpose of dining.
- (c) Liquor may be sold only on the following days and during the following hours:

 Monday to Saturday 7.00 am to 3.00 am the following day and Sunday 7.00 am to 11.00 pm (7.00 am to 12.00 midnight on the Thursday before Good Friday, Easter Saturday, Christmas Eve, and the day before ANZAC Day) to any person who is present on the premises.
- (d) Food shall be available for consumption on the premises as follows: At all times when the premises are authorised to be open for the sale of liquor, food of a range and style similar to that shown on any menu submitted or a range of snack foods in the nature of pies, sandwiches, filled rolls, pizzas and the like, shall be conveniently available for all patrons and the availability of those foodstuffs shall be notified t them by appropriate notices throughout the premises.
- (e) The whole of the premises is designated as a supervised area.
- (f) The licensee shall ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and shall display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

THE LICENSED PREMISES

In terms of Regulation 7 of the Sale of Liquor Regulations 1990 the sale, supply or consumption of liquor is authorised in the tavern only. The premises located at the corner of Main Street and Albert Street, Palmerston North are more precisely identified as outlined in a plan date stamped as received by the Liquor Licensing Authority on 22 October 1999

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence shall be displayed at the principal entrance to the premises. The entrance from the carpark off Ma Street is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence shall continue in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.

- The whole of the premises is designated as a supervised area. (c)
- The licensee shall ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited (d) persons are observed and shall display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

THE LICENSED PREMISES

In terms of Regulation 10 of the Sale of Liguor Regulations 1990 the sale or delivery of liguor is authorised in or from the tavern only. The premises located at the corner of Main Street and Albert Street, Palmerston North are more precisely identified as outlined in a plan date stamped as received by the Liquor Licensing Authority on 22 October 1999.
