### DECISION

Public notification of the application did not attract any objections or notices of desire to be heard. We deal with the matter on the papers.

The application is in respect of premises in which the principal business is the sale of liquor. Sales will be conducted via mail order, facsimile and the Internet.


We are satisfied as to the matters to which we must have regard as set out in s.35 of the Act, and we grant the applicant an off-licence. A copy of the licence setting out the conditions to which it is subject is attached to this decision.

The licence may issue immediately.

The applicants' attention is drawn to s.48 of the Act obliging the holder of an offlicence to display:-

- 1. A sign attached to the exterior of the premises, so as to be readily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of liquor <u>AND</u>
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance.

# OFF-LICENCE

Sections 29 and 114, Sale of Liquor Act 1989

PURSUANT to the Sale of Liquor Act 1989, the partnership of <u>GERALD PHILIP ALFRED ROBERTS and</u> <u>DIANE PATRICE ROBERTS</u> ("the licensee") is authorised to sell or deliver liquor on or from the premises situated at 31 Main North Road, Papanui, Christchurch, and known as "Cellarworks Wines", to any person for consumption off the premises.

The authority conferred by this licence shall be exercised by the licensee (if an individual) or through a \_\_\_\_\_ manager or managers appointed by the licensee in accordance with Part VI of the Act.

#### CONDITIONS

This licence is subject to the following conditions:

- No liquor shall be sold on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on ANZAC Day:
- (b) Liquor may be sold or delivered only on the following days and during the following hours:

#### Monday to Sunday 9.00 am to 11.00 pm

- (c) Order forms shall require customers to declare that they are of or over 18 years of age.
- (d) The licensee shall ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and shall display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sale to intoxicated persons.

#### THE LICENSED PREMISES

In terms of Regulation 10 of the Sale of Liquor Regulations 1990 the sale or delivery of liquor is authorised in or from the premises generally. The premises located at 31 Main North Road, Papanui, Christchurch are mc precisely identified as outlined in a plan date stamped as received by the Liquor Licensing Authority on 8 December 1999.

#### DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE

A copy of this licence shall be displayed at the principal entrance to the premises. The entrance from within the adjacent bottle store on Main North Road is designated as the principal entrance.

#### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence shall continue in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
