## DECISION

Public notification of the application did not attract any objections or notices of desire to be heard. We deal with the matter on the papers.

The general nature of the business undertaken is that of a tavern.


We are satisfied as to the matters to which we must have regard as set out in s.13 of the Act, and we grant the applicant an on-licence. A copy of the licence setting out the conditions to which it is subject is attached to this decision.

The licence may issue immediately.

The applicant's attention is drawn to s.25 of the Act obliging the holder of an onlicence to display:-

- 1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of liquor <u>AND</u>
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily ready by persons entering through each principal entrance.







## **ON-LICENCE**

## Sections 7 and 114, Sale of Liquor Act 1989

PURSUANT to the Sale of Liquor Act 1989, <u>LAKE END HOLDINGS LIMITED</u> is authorised to sell and supply liquent on the premises situated at Shop 4, Block C, Ground Floor, Steamerwharf Village, 88 Beach Street, Queenstown Queenstown-Lakes District and known as "Lagos Bar and Café", for consumption on the premises to any person who is present on the premises and to allow the consumption of liquor on the premises by any such person.

The authority conferred by this licence shall be exercised by the licensee (if an individual) or through a manager c managers appointed by the licensee in accordance with Part VI of the Act.

### **CONDITIONS**

This licence is subject to the following conditions:

- (a) The licensee shall have available for consumption on the premises, at all times when the premises are oper for the sale of liquor, a reasonable range of non-alcoholic refreshments.
- (b) No liquor is to be sold or supplied on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on ANZAC Day to any person other than persons who are present on the premises for the purpose of dining.
- (c) Liquor may be sold only on the following days and during the following hours: Monday to Sunday 7.00 am to 2.00 am the following day (7.00 am to 12.00 midnight on the Thursday before Good Friday, Easter Saturday, Christmas Eve, and the day before ANZAC Day) to any person who is present on the premises.
- (d) Food shall be available for consumption on the premises as follows: At all times when the premises are authorised to be open for the sale of liquor, food of a range and style similar to that shown on any menu submitted or a range of snack foods in the nature of pies, sandwiches, filled rolls, pizzas and the like, shall be conveniently available for all patrons and the availability of those foodstuffs shall be notified to them by appropriate notices throughout the premises.
- (e) Each of the following parts of the premises is designated as a supervised area: every bar.
- (f) The licensee shall ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and shall display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

### THE LICENSED PREMISES

In terms of Regulation 7 of the Sale of Liquor Regulations 1990 the sale, supply or consumption of liquor is authorised in the premises generally including the outdoor area. The premises located at Shop 4, Block C, Grour Floor, Steamerwharf Village, 88 Beach Street, Queenstown, Queenstown-Lakes District are more precisely identified as outlined in a plan date stamped as received by the Liquor Licensing Authority on 17 November 1999.

### DISPLAY OF LICENCE AND PRINCIPAL ENTRANCES

A copy of this licence shall be displayed at the principal entrance to the premises. The entrances from the Earnsl Wharf and adjacent to the stairs are designated as the principal entrances.

### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to t suspension and cancellation of licences, this licence shall continue in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
