DECISION

Public notification of the application did not attract any objections or notices of desire to be heard. We deal with the matter on the papers.

The general nature of the business to be undertaken is that of a tourist house with associated restaurant and function facilities.

We are satisfied as to the matters to which we must have regard as set out in s.13 of the Act, and we grant the applicant an on-licence. A copy of the licence setting out the conditions to which it is subject is attached to this decision.

The licence may issue immediately.

The applicant's attention is drawn to s.25 of the Act obliging the holder of an on-licence to display:-

1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of liquor AND
2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily ready by persons entering through each principal entrance.

**ON-LICENCE**

Sections 7 and 114, Sale of Liquor Act 1989

PURSUANT to the Sale of Liquor Act 1989, **ATTILIO ALUNNO** is authorised to sell and supply liquor on the premises situated at 101 Milson Line, Palmerston North and known as "Sheraton El Burcio", for consumption on the premises to any person who is present on the premises and to allow the consumption of liquor on the premises by any such person.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Part VI of the Act.

**CONDITIONS**

This licence is subject to the following conditions:

- (a) The licensee must have available for consumption on the premises, at all times when the premises are open for the sale of liquor, a reasonable range of non-alcoholic and low-alcohol refreshments:
- (b) No liquor is to be sold or supplied on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on ANZAC Day to any person other than persons who are:
  - (i) For the time being living on the premises whether as a lodger or an employee of the licensee or otherwise; or
  - (ii) Present on the premises for the purpose of dining
- (c) Liquor may be sold only on the following days and during the following hours:
  - (i) At any time on any day to any person who is for the time being living on the premises.
  - (ii) Monday to Sunday 7.00 am to 3.00 am the following day (7.00 am to 12.00 midnight on the Thursday before Good Friday, Easter Saturday, Christmas Eve and the day before ANZAC Day) to any other person who is present on the premises.
- (d) Food must be available for consumption on the premises as follows:  
At all times when the premises are authorised to be open for the sale of liquor, food of a range and style similar to that shown on any menu submitted or a range of snack foods in the nature of pies, sandwiches, filled rolls, pizzas and the like, must be conveniently available for all patrons and the availability of those foodstuffs must be notified to them by appropriate notices throughout the premises.
- (e) Each of the following parts of the premises is designated as a supervised area: Any bar.
- (f) The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.
- (g) The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of liquor.
- (h) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

**THE LICENSED PREMISES**

In terms of Regulation 7 of the Sale of Liquor Regulations 1990 the sale, supply or consumption of liquor is authorised in the premises generally including the deck area. The premises situated at 101 Milson Line, Palmerston North are more precisely identified as outlined in a plan date stamped as received by the Liquor Licensing Authority on 20 January 2000.

**DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S**

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Milson Line is designated as the principal entrance.

**DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Part VI of the Act.

**CONDITIONS**

This licence is subject to the following conditions:

- (a) No liquor is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on ANZAC Day;
- (b) No liquor is to be sold other than:
  - (i) Wine that conforms to the standard prescribed by Regulation 219 of the Food Regulations 1984 (SR 1984/262), or any other standard that may be prescribed pursuant to the Food Act 1981 in substitution for that standard; and
  - (ii) Sparkling wine that conforms to the standard prescribed by Regulation 220 of those Regulations, or any other standard that may be prescribed pursuant to the Food Act 1981 in substitution for that standard; and
  - (iii) Fruit wine that conforms to the standard prescribed by Regulation 226 of those Regulations, or any other standard that may be prescribed pursuant to the Food Act 1981 in substitution for that standard; and
  - (iv) Sparkling fruit wine that conforms to the standard prescribed by Regulation 227 of those Regulations, or any other standard that may be prescribed pursuant to the Food Act 1981 in substitution for that standard; and
  - (v) Mead that conforms to the standard prescribed by Regulation 226 of those Regulations, or any other standard that may be prescribed pursuant to the Food Act 1981 in substitution for that standard; and
  - (vi) Beer that conforms to the standard prescribed by Regulation 218 of those Regulations, or any other standards that may be set by Regulations made under the Food Act 1981 or by food standards issued under that Act, in substitution for that standard.
- (c) Liquor may be sold or delivered only on the following days and during the following hours:  
**Monday to Sunday 7.00 am to 10.00 pm**
- (d) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

**THE LICENSED PREMISES**

In terms of Regulation 10 of the Sale of Liquor Regulations 1990 the sale or delivery of liquor is authorised in or from the premises generally.
