1968, No. 5—Private

An Act to amend the Otago Presbyterian Church Board of Property Act 1962 [25 November 1968]

WHEREAS the Otago Presbyterian Church Board of Property is presently duly incorporated under the provisions of the Otago Presbyterian Church Board of Property Act 1962 (hereinafter referred to as "the principal Act"): And whereas because of confusion which more recently has arisen over the name of the Board and in order that the Board may have a name which associates it and the funds it administers with its origin the Board and the Synod have agreed to change the name to the Otago Foundation Trust Board: And whereas as a result of changing circumstances and recent experiences it has become desirable for the Board to have power to sell additional lands to those authorised by the principal Act: And whereas similar recent experiences have shown that for the better administration of the lands vested in the Board the powers of the Board to lease such lands and any buildings or parts thereof respectively require to be varied and enlarged: And whereas for the better and wider investment of available funds it is deemed desirable for the Board to have power to purchase freehold land and buildings and improvements on freehold land both within and outside the Provincial District of Otago:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

- 1. Short Title—This Act may be cited as the Otago Foundation Trust Board Amendment Act 1968, and shall be read together with and deemed part of the principal Act.
- 2. Alteration of Short Title of principal Act—(1) The principal Act may hereafter be cited as the Otago Foundation Trust Board Act 1962.
- (2) Every reference in any enactment or document whatsoever to the Short Title of the principal Act is consequentially amended by omitting the words "Presbyterian Church Board of Property", and substituting therefor the words "Foundation Trust Board".
- 3. Consequential changes of names—(1) Whenever in the principal Act or in any other enactment or document whatsoever the words "the Otago Presbyterian Church Board of Property" are used the same shall be amended by omitting the words "Presbyterian Church Board of Property", and substituting therefor the words "Foundation Trust Board".

(2) Wherever in the principal Act or in any other enactment or document whatsoever the term "the Board" or "the Church Board" is used to describe the Otago Presbyterian Church Board of Property, unless the context otherwise requires, the reference shall hereafter be read as a reference to

the Otago Foundation Trust Board.

(3) Where the title of the Otago Presbyterian Church Board of Property to any real or personal property or right is or should have been entered on any register required by law to be kept, the Registrar or other person whose duty it is to keep that register shall, on request in writing of the Board, without payment of any fee make such entries in the register as may be necessary to give effect to the provisions of this section.

(4) The presentation to any Registrar of Deeds or any District Land Registrar or any other person of an instrument duly executed in the name of the Otago Foundation Trust Board and relating to any estate or interest in any land or other property vested in the Otago Presbyterian Church Board of Property immediately before the commencement of this Act shall, notwithstanding that the present name has not been entered in the appropriate register, be accepted by all persons concerned as conclusive proof that the estate or interest is vested in the Board in its present name.

- 4. Schedule A lands changed—Schedule A of the principal Act is hereby amended by omitting from the first part thereof and adding to the second part thereof, the lands described or referred to in the Schedule hereto.
- 5. Leasing powers—Section 12 of the principal Act is hereby amended by repealing paragraphs (c) and (d), and substituting the following paragraphs:
  - (c) To lease all or any part or parts of the lands now or hereafter vested in the Board, or any building or part of a building for the time being standing on any such land or on any part or parts of such land or on any other land on any of the tenancies or leases following:

"(i) A tenancy at will:

"(ii) A tenancy terminable by the Board at any time by six months' notice or any shorter notice:

"(iii) A tenancy for any term not exceeding fifty years, without right of renewal:

- "(iv) A tenancy with a right of renewal for one or more terms, at a rent to be fixed by agreement between the Board and the lessee or that failing by arbitration but so that the aggregate duration of the original and of the renewed terms shall not exceed fifty years:
- "(v) A tenancy for any term not exceeding twenty-one years, with a perpetual right of renewal for the same or any shorter term at a rent to be fixed by agreement between the Board and the lessee or that failing by arbitration:
- "(vi) A tenancy for any term not exceeding twenty-one years with a provision that on or before the expiration of the term a new lease for the same or any shorter term shall be offered for sale by auction and so on from time to time in perpetuity:
- "(vii) A tenancy in accordance with either of the two last preceding paragraphs, save that the right of renewal or re-leasing the premises comprised therein or of having a new lease offered for sale by auction is limited in duration in such manner as the Board thinks fit, in lieu of being perpetual:

"Provided that any lease of any part of the land described in Schedule C to the principal Act shall be granted by the Board upon a request in writing addressed to the Board by a person duly authorised in that behalf by Synod:

"(d) In any tenancy or lease as aforesaid to enter into such agreements with the tenant or lessee as the Board in each case shall deem appropriate, for-

"(i) Adjusting the rent at such intervals as the

Board may determine:

"(ii) Renewing the tenancy or lease or for re-

leasing the premises comprised therein:

"(iii) The payment by the incoming tenant or lessee to the outgoing tenant or lessee or to the Board on behalf of the latter, of the value determined as in the lease provided of any buildings or other improvements which may belong to the outgoing tenant or lessee, provided that the payment of such value shall not be deemed to be a fine or premium:

"(iv) Re-leasing such premises to the tenant or lessee in the event of no other person becoming

entitled to a tenancy or lease thereof:

- "(dd) In any tenancy or lease as aforesaid there shall be contained such powers of re-entry and forfeiture and such covenants agreements conditions and provisions as the Board in each case deem appropriate."
- 6. Power to purchase further lands—Paragraph (g) of section 12 of the principal Act is hereby amended by omitting therefrom the words "in the Provincial District of Otago".
- 7. Private Act—This Act is hereby declared to be a private Act.
