## A BILL INTITULED

An Acr to amend the Dogs Registration Act, 1908. Title. BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority 5 of the same, as follows:—

1. (1) This Act may be cited as the Dogs Registration short Title Amendment Act, 1937, and shall be read together with and and deemed part of the Dogs Registration Act, 1908 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the first day of 10 January, nineteen hundred and thirty-nine.

2. In this Act "approved remedy" means any Interpretation. substance or preparation prescribed as a remedy for the cure or prevention of disease in dogs caused by 15 infection from the parasite Echinococcus granulosus.

3. (1) There shall be kept by the local authority at Approved every registration office a sufficient supply of approved be kept and remedies.

(2) At the time of registration the Registrar shall supply to every person registering a dog a sufficient amount of an approved remedy to enable that person to treat the dog until the first day of January next following the date of registration. There shall also be supplied with the approved remedy printed instructions

in the prescribed form for its use. **4.** (1) In addition to the fee payable under the principal Act for the registration of a dog there shall be payable in respect of the supply of an approved 10 remedy as aforesaid a fee of the prescribed amount.

(2) Until payment of the additional fee registration shall not be deemed to have been duly made.

5. The Minister of Internal Affairs may make such arrangements as he thinks fit for the supply to 15 local authorities of approved remedies and of printed instructions to accompany such remedies.

**6.** The Governor-General may from time to time, by Order in Council, make regulations—
