FINANCE BILL

EXPLANATORY NOTES

PART I-PUBLIC REVENUES AND LOANS

- Clause 2: Authorizing regulations to make New Zealand Government securities registered in United Kingdom transferable by instrument in writing and in no other manner.—This clause authorizes the making of regulations in the United Kingdom providing for the transfer of New Zealand Government securities registered under the Colonial Stock Acts, 1877 to 1948, by instrument in writing and in no other manner. This method of transfer has been in force temporarily during the Second World War, and replaces the former method of transfer by inscription in the books of the Bank of England, which involved the personal attendance at the Bank of the stockholder or his attorney.
- Clause 3: Date of maturity of Death Duty stock.—This clause re-enacts section 40 (3) of the New Zealand Loans Act, 1932, so as to make it clear that, where Death Duty stock is transferred to the Commissioner of Stamp Duties to pay death duty, the stock shall mature on, and carry interest till, the date of the execution of the transfer, and that the stock will be deemed to be accepted by the Commissioner of Stamp Duties in satisfaction of death duties on that date. The present provision in section 40 (3) of the New Zealand Loans Act, 1932, leaves doubt as to whether the material date for these purposes is the date of the execution of the transfer or the date on which the transfer is handed to the Commissioner.
- Clause 4: Validating excess unauthorized expenditure.—This clause validates excess unauthorized expenditure by Government Departments for the financial year that ended on the 31st March, 1950. This exceeded the limits prescribed by law by £772,590 15s. 3d.
- Clause 5: Acquisition of shares in East Coast Farmers' Fertilizer Company, Limited.—This clause authorizes the acquisition of shares in the East Coast Farmers' Fertilizer Company, Limited, on behalf of the Crown by the State Advances Corporation. It validates the acquisition of the shares already acquired by the Minister of Finance.
- Clause 6: National development loans in anticipation of Appropriation Act.—This clause authorizes the raising of national development loans in anticipation of the Appropriation Act for any year, either before or after the commencement of the financial year, up to the amount authorized to be raised by virtue of the Appropriation Act last passed.

- Clause 7: Authorizing expenditure from Defence Fund.—This clause provides for the expenditure of moneys from the Defence Fund within the Public Account, without further appropriation, for purposes connected with the defence of New Zealand, and also authorizes the Minister of Finance to determine any question as to whether any moneys are properly payable out of the Fund.
- Clause 8: Authority to finance suspensory loans.—This clause provides a permanent authority for the payment out of the Consolidated Fund to the State Advances Corporation Account and to the Land Settlement Account of moneys required to meet commitments or anticipated commitments for advances in respect of suspensory loans.
- Clause 9: Authorizing granting of rehabilitation loans out of repayments.— This clause authorizes the State Advances Corporation to use moneys received in repayment of rehabilitation loans for the purpose of making further loans and grants under the Rehabilitation Act, 1941. The clause applies where the moneys for the loans were provided out of the War Expenses Account.
- Clause 10: Transfer of surplus funds from Consolidated Fund to Public Works Account.—This clause authorizes the Minister of Finance to direct the transfer to the Public Works Account of surplus funds in the Consolidated Fund.
- Clause 11: Validating fees, allowances and travelling allowances paid to members of statutory Boards at rates approved by Minister of Finance.—Various regulations have recently been made increasing the rates of fees, allowances, and travelling allowances, or providing for their payment. This clause validates payments of fees, allowances, and travelling allowances which have been made before the passing of this Bill with the approval of the Minister of Finance in anticipation of authorizing regulations.
- Clause 12: Grant for Maori purposes.—This clause provides for the annual grant of £7,000 for Maori purposes for which grant provision has previously been made by section 23 of the Civil List Act, 1920.
- Clause 13: War Memorials Subsidies Deposit Account.—This clause authorizes the transfer of moneys appropriated by Parliament from time to time for the purpose of subsidizing war memorials to a special deposit account, to be held until required.
- Clause 14: Post Office profits.—This clause provides that in computing the amount of the Post Office profits to be paid into the Consolidated Fund in respect of the financial years which ended on 31st March, 1948, and 31st March, 1949, there may be deducted the amount of the loss for the year ended 31st March, 1950. In computing profits in future years there may be deducted the amount of any loss for any previous financial year not earlier than the year ending on the 31st March, 1951.
- Clause 15: Meat Pool Account and Meat Industry Stabilization Account to be amalgamated and known as the Meat Industry Reserve Account.—This clause abolishes the Meat Pool Account and the Meat Industry Stabilization Account and transfers the moneys in these two accounts to a new account within the Meat Industry Account to be known as the Meat Industry Reserve Account. All moneys which, apart from the clause, would have been payable into or out of the two abolished accounts are to be paid into or out of the new account.

Clause 16: Government Fire Insurance Fund.—Section 133 of the Public Revenues Act, 1926, provides for an annual payment of £10,000 to the Government Fire Insurance Fund, so long as the Fund does not exceed £100,000. This clause removes the limitations so that whatever amount is deemed necessary may be appropriated for the Fund each year.

Clause 17: Exemption from duty of gifts to United Nations appeal for children.—This clause provides that gifts made in response to the appeal made by the United Nations in 1950 to the fund for distressed children in overseas countries shall be exempt from gift duty and shall not be brought into the dutiable estate of the donor for death duty purposes. A similar provision was made by section 19 of the Finance Act, 1948, in respect of the appeal made by the United Nations in 1948.

Clause 18: Exemption of rugby league football from amusements tax.—This clause provides for exemption from amusements tax for entertainments consisting of games of rugby league football played by teams of persons ordinarily resident in New Zealand if the Commissioner of Stamp Duties is satisfied that during the year which ended on the 31st December immediately preceding the game no person received from the New Zealand Rugby Football League (Incorporated) or from any body affiliated to it any payment for playing rugby league football other than for reasonable travelling expenses or to compensate for wages lost.

Clause 19: Additional exemptions from sales tax.—This clause gives effect to the resolution passed by the House of Representatives on 24th August, 1950, exempting various classes and kinds of goods from sales tax.

Clause 20: Repeal of provisions for Customs drawback debentures and declarations thereon.—This clause repeals the provisions in the Customs Act, 1913, relating to drawback debentures and declarations thereon so as to obviate the necessity for these debentures and simplify the procedure for obtaining drawbacks of duty on goods exported.

Clause 21: Retrospective effect of certain Post Office regulations.—This clause gives retrospective effect to certain regulations which increased Post Office charges so as to make the increases have effect on and after the 16th July, 1950.

PART II-HOUSING

Clause 22: This Part to be read with Housing Act, 1919.—This clause provides that Part II of the Bill is to be read together with and deemed part of Part I of the Housing Act, 1919, which relates to worker's dwellings.

Clause 23: Sale of State houses.—This clause provides that, subject to any direction of the Minister of Finance, State houses and other worker's dwellings may be sold for cash or under an agreement for sale in such manner, at such price, and on such terms and conditions as the Board of Management of the State Advances Corporation thinks fit. Express authority is given to the Board to allow discounts for early payment of the selling price; to remit any unpaid balance of the selling price if the purchaser, or a specified wage earner of the purchaser's household, dies before attaining a specified age and a premium payment has been made; to impose conditions in respect of resale and personal residence; and to allow a reduced rate of interest and remit part of the selling price where the conditions of sale are complied with.

- Clause 24: Licences to occupy.—Where title cannot be given in the normal way on account of survey difficulties or roads not having been formed the purchaser may be granted a licence to occupy.
- Clause 25: Registration of agreements and licences.—This clause provides machinery for the registration of agreements and licences under the Land Transfer Act, 1915, notwithstanding that any plans required under that Act have not been deposited.
- Clause 26: Corporation may execute transfers.—This clause empowers the Corporation to execute transfers of State houses on behalf of the Crown.
- Clause 27: Repeals and revocation.—This clause provides for consequential repeals, and for the revocation of the Housing Regulations 1942 which are not appropriate in connection with the new scheme.

PART III—LOCAL AUTHORITIES AND PUBLIC BODIES

- Clause 28: Publication of proposal under Local Bodies' Loans Act, 1926.— This clause provides that in connection with loan proposals involving a poll there is in future to be one set of notices which shall give particulars of the proposal and the date of the poll.
- Clause 29: How poll to be taken under Local Bodies' Loans Act, 1926.— This clause recasts Section 11 of the Local Bodies' Loans Act, 1926, omitting the provisions regarding notices which are now covered by the last preceding clause
- Clause 30: Purposes for which Bridge Fund may be used.—This clause extends the purposes for which the Bridge Fund of a County Council may be applied so as to enable it to be used to meet the principal (in addition to the interest and other charges) on loans raised for the purpose of renewing bridges, and to meet the principal, interest, and other charges on loans raised to repay loans which have been raised for any such purpose.
- Clause 31: Loans for renewal of bridges.—This clause amends section 25 of the Local Bodies' Loans Act, 1926, so as to enable a County Council to raise a loan without a poll to renew a bridge of any length where the renewal is necessary by reason of flood, fire, mischance, or disrepair. At present a loan can be so raised in these circumstances only where the bridge exceeds 20 feet in span.
- Clause 32: Authorizing and validating certain expenditure by local authorities in respect of the British Empire Games.—This clause authorizes and validates expenditure incurred by local authorities or public bodies, in respect of the British Empire Games held in New Zealand in February, 1950, for the purpose of entertaining competitors or visitors who attended these games or for the purpose of taking part in any celebration or display in connection with the games or for the purpose of contributing towards the cost of any publication or souvenir booklet advertising or commemorating the games.
- Clause 33: Authorizing and validating expenditure by local authorities in respect of Commonwealth Parliamentary Association Conference, 1950.—Many local authorities throughout New Zealand will be incurring expenditure in connection with the reception and entertainment of delegates to the Commonwealth Parliamentary Association Conference, 1950. This clause provides the necessary authority for such expenditure and also validates any expenditure which may have already been incurred.

- Clause 34: Validating contributions to United Nations appeal for children.—This clause validates payments made by any local authority or public body out of its general fund or account in response to the appeal for overseas children made by the United Nations in 1950.
- Clause 35: Empowering local authorities that are members of South Island Local Bodies' Association to pay subscriptions to Association and to pay certain travelling expenses.—This clause authorizes any local authority that is a member of the South Island Local Bodies' Association to pay out of its general fund or account any subscriptions, not exceeding a total of £10 10s. a year, payable by it under the rules of the Association. It also authorizes any such local authority to pay from its general fund or account the reasonable travelling expenses of its representatives incurred in attending meetings of the Association or its executive.
- Clause 36: Power of New Zealand Counties Association to purchase and sell roadmaking machinery.—This clause authorizes the Counties Association to purchase roadmaking machinery, plant, equipment, and appliances and resell it to the counties which are members of the Association. The Association may allow the purchase price to be paid by instalments extending over not more than four years, with interest on the balance of purchase money for the time being unpaid.
- Clause 37: Power of constituent local authority of milk district to hold shares in milk treatment company, and to borrow for that purpose.—Section 5 of the Milk Amendment Act, 1947, authorizes Milk Authorities to acquire shares in companies whose principal business is the treatment of milk. This clause gives the same power to constituent local authorities of milk districts, and authorizes the local authorities to borrow moneys to acquire the shares and pay calls.
- Clause 38: Authorizing Christchurch Metropolitan Milk Board to borrow for payment of calls on shares in Christchurch Milk Company, Limited.—Under section 5 of the Milk Amendment Act, 1947, the Christchurch Metropolitan Milk Board acquired shares in the Christchurch Milk Company, Limited, which is engaged in the treatment of milk. The borrowing powers given to Milk Authorities by section 60 of the Milk Act, 1944, are not wide enough to include borrowing for the purpose of meeting the calls on these shares. This clause authorizes the Board to borrow for that purpose.

PART IV

MISCELLANEOUS

Clause 39: Members of General Assembly not to be disqualified by receipt of allowances for travelling as representatives of Parliament.—This clause provides that members of the General Assembly are not to be disqualified by the receipt of payments from public moneys in connection with their attendance at conferences of the Commonwealth Parliamentary Association, or their attendance at other conferences, meetings, or ceremonies, or travelling on any missions or business, as representatives of Parliament or with the authority of the Legislative Council or the House of Representatives as the case may be.

Clause 40: Provisions as to disqualification of members of Parliament not to apply in certain cases.—This clause provides that the disqualification provisions are not to apply to the Hon. W. S. Goosman in respect of the acquisition of certain land for the settlement of discharged servicemen from his wife and from a company of which he is a director; or to Mr. W. B. Tennent, M.P., in respect of his services as a contracting dentist under the Social Security Act, 1938, until the contract was terminated on 10th February, 1950.

Clause 41: Duration and termination of the war with Germany, Austria, and Japan.—This clause declares that a state of war still exists between New Zealand and Germany, Austria, and Japan, and will continue in respect of each of those States until it is ended by a Proclamation by the Governor-General relating to the particular State concerned. Subclause (5) repeals—

(a) Section 16 of the Finance Act, 1945, which defined the duration of the Second World War on the assumption that it would be ended by one general Proclamation, and has become unsuitable in view of the likelihood that the state of war with each of the countries concerned will be terminated separately; and

(b) Section 24 of the War Legislation and Statute Law Amendment Act, 1918, which defined the duration of the First World War, and may

now be regarded as spent.

The clause also provides that contracts and wills referring to the date of the end of the war or the declaration of peace are to be construed as if that date were 1st December, 1950, unless the context otherwise requires or the parties can show that another date was intended.

Clause 42: Validating and modifying agreement as to supply of electricity in Invercargill.—By an agreement dated 7th April, 1925, the Southland Electric Power Board agreed that if any area became incorporated in the Borough of Invercargill the Board would sell to the Borough Corporation all the electrical supply works in that area. Invercargill has now become a city, and the property and contracts of the Power Board have been taken over by the Crown. Doubts having arisen as to the validity of the agreement, this clause validates it in respect of the areas already incorporated in the city and in respect of other areas proposed to be incorporated. The clause also provides for the payment of purchase money by the City Corporation being made by quarterly instalments over a period of five years.

Clause 43: Power to increase superannuation allowance of Judges in certain cases.—A Judge of the Supreme Court who retires on the ground of illness, or on reaching the retiring age, after not less than five and not more than ten years' service is entitled to a superannuation allowance ranging according to the length of service from three twenty-fourths to six twenty-fourths of his salary (that is, from £281 5s. to £562 10s. a year when based on the present salary of £2,250). This clause gives a discretionary power to the Governor-General in Council to increase the allowance, in any case where it is necessary, up to two ninths of the salary (that is, to £500 on the basis of the present salary).

Clause 44: Authorizing Public Trustee to purchase shares in East Coast Farmers' Fertilizer Company, Limited, out of revenues of Howard Estate.—This clause authorizes up to £250 to be expended out of the revenues of the Howard Estate in the purchase of shares in the East Coast Farmers' Fertilizer Company, Limited. The Howard Estate comprises substantial areas of land

which are administered by the Public Trustee as an endowment for the purpose of agricultural education. It is anticipated that the estate will benefit from the purchase of the shares through rebates and discounts on manures, &c., which are purchased for use on the land, as well as through dividends.

Clause 45: Certain railway deviations authorized.—This clause authorizes the construction of railway deviations necessitated by the proposed erection of a new railway bridge over the Waimakariri River near Kaiapoi and the proposed re-arrangement of the railway facilities at Stratford; and the construction of the Edgecumbe-Murupara Railway.

Clause 46: Control of Kawarau Falls Dam.—The dam across the Kawarau River at the outlet from Lake Wakatipu was built under a licence which was granted in 1924 under the Mining Act, 1908, and is now vested in the Crown. The dam will need to be used in conjunction with the Roxburgh hydro-electric scheme, and this clause places the dam in the same position as the other works authorized for the purposes of that scheme. The existing licence is preserved but its purposes are changed so as to permit the stored water to be used for generating and storing electrical energy instead of for mining purposes. The Kawarau Gold Mining Amalgamation Act, 1930, is now spent, and is repealed. The special Board set up to control the dam has ceased to function; and the Order in Council constituting it is revoked. It is declared that the special conditions of the 1924 licence which are not relevant in the changed circumstances shall cease to have effect.

Clause 47: Disposal of private and special funds and canteen stores profits of Second New Zealand Expeditionary Force.—This clause authorizes—

- (a) The payment of the private and special funds of the Second New Zealand Expeditionary Force to the Canteen Fund established under the Patriotic and Canteen Funds Act, 1947; and
- (b) The payment of the canteen stores profits of the Second New Zealand Expeditionary Force to the New Zealand Patriotic Fund established under that Act.

Clause 48: Validating gift to Army Board by New Zealand Patriotic Fund Board.—This clause validates the gift made to the Army Board by the New Zealand Patriotic Fund Board of sporting goods, &c., provided by the Patriotic Fund Board for the use of New Zealand troops in Japan, and now transferred for the general use of the Army.

Clause 49: Staff of Licensing Control Commission to be employees of the Public Service.—This clause provides for the Secretary and other members of the staff of the Licensing Control Commission to be appointed as employees of the Public Service instead of being appointed by the Licensing Control Commission. The term "employee" is substituted for the term "officer", because under the Public Service legislation the latter term excludes probationers and temporary employees.

Clause 50: Special rate in respect of coal shipped from Westport.—Section 8 of the Westport Harbour Act, 1920, imposes a special rate of 1s. in respect of every ton of coal brought for shipment in the Port of Westport. The purpose of this clause is to authorize that rate to be increased to 4s. a ton with the consent of the Minister of Marine.

- Clause 51: Superannuation rights of Sir Howard Kippenberger.—This clause provides for the payment of a superannuation annuity of £500 to Sir Howard Kippenberger as from his retirement from the position of Editor in Chief of the War History Branch of the Department of Internal Affairs until his death; and for the payment of an annuity of £250 to his widow after his death during her widowhood.
- Clause 52: Repeal of Mortgagees' Indemnity (Workers' Charges) Act, 1927.—This clause repeals this Act in view of the provisions under the Workers' Compensation legislation for employers' liability insurance.

A BILL INTITULED

Title.

An Act to Make Provision With Respect to Public Finance and Other Matters.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

Short Title.

1. This Act may be cited as the Finance Act, 1950.

PART I

Public Revenues and Loans

2. (1) This section shall be read together with and Authorizing deemed part of the New Zealand Loans Act, 1932 (in this 5 section referred to as the principal Act).

(2) An agreement entered into under section twentythree of the principal Act may provide for registering any stock in a register kept in the United Kingdom by the Bank of England or by any other bank and for issuing

10 certificates of title relating to any such stock.

(3) Where any stock issued under the principal Act is, pursuant to an agreement under section twenty-three of the principal Act, inscribed or registered in a register kept in the United Kingdom by the Bank of England or 15 by any other bank (in this section referred to as the registrar), and is registered under the Colonial Stock Acts, 1877 to 1948, of the Parliament of the United Kingdom, or any Acts amending them or substituted therefor, regulations may be made by the registrar 20 under section sixteen of the Colonial Stock Act, 1877, as extended by section one of the Colonial Stock Act, 1948, of the Parliament of the United Kingdom, for the purpose of providing that the stock shall be transferable by instrument in writing in accordance with the regulations and in 25 no other manner.

- (4) This section applies to stock issued before, as well as to stock issued after, the passing of this Act, and accordingly, in relation to stock issued before the passing of this Act, so much of the said section sixteen as requires 30 regulations thereunder to be made before the issue of the stock shall not apply to regulations made for the purpose specified in subsection three of this section, and the regulations, when made, shall have effect notwithstanding anything in any previous regulations applicable 35 to the stock and notwithstanding anything in the terms on which the stock was issued.
 - 3. Section forty of the New Zealand Loans Act, 1932, Date of is hereby amended by repealing subsection three, and substituting the following subsection:—

mature for payment, and to be accepted by the Commissioner of Stamp Duties in satisfaction of death duties as aforesaid, on the date of execution of the transfer by the transferor; and all such stock shall for the purposes of this section be deemed to be of the nominal value thereof and shall carry interest till that date."

4. All sums issued under section fifty-eight of the Public Revenues Act, 1926, during the financial year that ended on the thirty-first day of March, nineteen hundred and fifty, in excess of the limits prescribed by subsection 10 three of that section (as substituted by section seven of the Finance Act, 1947) are hereby declared to have been lawfully issued and paid.

5. (1) The State Advances Corporation of New Zealand may from time to time, on behalf of His Majesty 15 the King, subscribe for or otherwise acquire shares or interests in the East Coast Farmers' Fertilizer Company. (b) Allow the remission of the whole or any part of the unpaid balance of the selling price, on the death of the purchaser or of any other specified person whom the Board considers to be the wage earner of the purchaser's household before the purchaser or specified person attains an age to be fixed by the Board, in consideration of a payment of such amount, or of an increase of the selling price by such amount, as the Board may determine:

(c) Make the sale conditional on the dwelling not being sold within a specified period fixed by the Board without the dwelling being offered to the Crown at a price to be agreed upon or

(d) Make the sale conditional on the purchaser remaining the sole owner of the dwelling for a specified period fixed by the Board, and on the purchaser residing and making his home in 20 the dwelling and not parting with possession of it during that period; and may permit these conditions to be fulfilled, in the event of the purchaser's death, by a specified member of the purchaser's household approved 25 by the Board either at the time of sale or subsequently:

Whereas New Zealand is at war with Germany, Duration and Austria, and Japan, and it is expedient to make provision for the termination of the state of war with each of Germany, those States separately and also to declare what date Austria, and is to be treeted as the date of the self-the 5 is to be treated as the date of the end of the war for the purposes of contracts and wills: Be it therefore enacted as follows:-

(1) The state of war between New Zealand and any of those States shall be deemed to be existent until a 10 date to be specified as the date of the termination of the state of war with that State in a Proclamation by the Governor-General published in the Gazette.

(2) Notwithstanding the foregoing provisions of this section, the date to be treated for the purposes of any 15 contract or will as the date of the end of the war and as the date of the declaration of peace in respect of all the States with which New Zealand has been at war at any time since the third day of September, nineteen hundred and thirty-nine, and as the date of 20 the end of the emergency (not being defined by reference to any Act) occasioned thereby, shall be the first day of December, nineteen hundred and fifty, and every contract or will shall be construed accordingly, unless the context requires, or it is shown by admissible evi-25 dence, that it should be otherwise construed.

(3) For the purposes of subsection two of this section, the Court by which any contract or will is construed may admit any evidence which in the opinion of the Court may throw light on the intention of the 30 party or parties as to the meaning of the contract or will.

(4) In this section the expression "contract or will "means any agreement, memorandum, deed, will, or other instrument, not being a tenancy agreement to which the Tenancy Agreements (End of the War) Order 1947 35 applies, and not being an Act or a regulation.

Validating and modifying agreement as to supply of electricity in Invercargill.

42. Whereas by an agreement dated the seventh day of April, nineteen hundred and twenty-five, and made between the Southland Electric Power Board of the one part, and the Corporation of the Borough of Invercargill (now the City of Invercargill), of the other part, a copy whereof has been deposited in the office of the Minister, the Board purported to agree, among other things, that if and whenever the boundaries of the borough should be so altered that any area outside the borough should be brought within the borough, then the electrical supplies 10 of any and every such area should revert to the Corporation, and the Board should sell to the Corporation and the Corporation should purchase from the Board all such electrical works, plant, lines, mains, supports, and other apparatus within any such area as were necessary and 15 solely used for the electrical supplies thereof, and were the property of the Board, and the price thereof should be ascertained by valuation in accordance with the provisions of the said agreement: And whereas by virtue of the Southland Electric Power Supply Act, 1936, all 20 land and other property, whether real or personal, belonging to the Board has become vested in His Majesty the King, and all rights, liabilities, and engagements of the Board have become rights, liabilities, and engagements of the Crown, and the undertaking theretofore 25 carried on by the Board is being carried on by the Minister in accordance with the provisions of the State Supply of Electrical Energy Act, 1917: And whereas the areas described in Part I of the Second Schedule to this Act have been incorporated within the City of 30. Invercargill since the date of the said agreement, and the areas described in Part II of that Schedule are now proposed to be incorporated within the City, but all the aforesaid areas are situated within the former Southland Electric Power District, and are supplied with electri- 35 city by the Minister notwithstanding the said agreement: And whereas doubts have arisen as to the legal effect of the said agreement, and it is desirable that those doubts be removed in order that the said agreement may be put into effect in the manner and to the extent 40 hereinafter appearing:

(2) The Minister shall, notwithstanding anything to the contrary in the Southland Electric Power Supply 1936, No. 25 20 Act, 1936, or in any other enactment, but subject to the provisions of this section, sell to the Corporation, and the Corporation shall purchase from the Minister, all the electric lines or works the property of His Majesty the King which are situated within the areas described 25 in the Second Schedule to this Act and are necessary and solely used for the purpose of supplying electricity therein.

(3) The price for the aforesaid electric lines or works shall be fixed by agreement between the Minister and 30 the Corporation, and failing agreement shall be ascertained by valuation in accordance with the provisions of the said agreement.

(4) The price, or so much thereof as relates to the electric lines or works sold by the Minister and purchased 35 by the Corporation in any one quarter, shall at the option of the Corporation be paid in one sum or in quarterly instalments spread over a period of not more than five years, the first of those instalments to become due and owing on the last day of the quarter in which 40 the electric lines or works are sold and purchased.

(5) Interest shall be paid quarterly on so much of the price as from time to time remains owing by the Corporation, at the rate for the time being prescribed

by the Minister of Finance to be paid on amounts transferred from the National Development Loans Account to the Electric Supply Account, pursuant to the National Development Loans Act, 1941, or, if a higher rate is for the time being payable on any moneys in the Electric Supply Account that may be borrowed from any source other than the National Development Loans Account, then at that higher rate.

(6) As from the date of the sale and purchase of any of the said electric lines or works as aforesaid, 10 the Corporation shall, subject to the provisions of this section, be entitled to undertake the supply of electricity within the area wherein the electric lines or works sold to the Corporation are situated, and upon the Corporation commencing the supply of electricity as aforesaid 15 the Minister shall cease the supply of electricity therein.

(7) In supplying electricity as aforesaid within the said areas or any part of them, the Corporation shall comply with the provisions of the Public Works Act, 1928, and of all other enactments affecting the Corpo- 20 ration in that behalf.

(8) On completion of the sale and purchase of the electric lines or works as aforesaid, the said agreement shall be deemed to be finally satisfied and discharged.

(9) Nothing in this section shall apply in respect of 25 any part of the areas described in Part II of the Second Schedule to this Act, until that part has been incorporated within the City.

Polishes, viz.: boot, floor, furniture, linoleum, metal, and stove.

Pot mitts and metal wool.

Racing boats and sculls for rowing clubs.

Sacramental vessels, and other articles as may be approved, for use for religious purposes in Churches.

Sandsoap.

Sheeting, plastic, pliable, suitable for the manufacture of apparel and soft furnishings.

Silver nitrate crystals.

Soap pastes in admixture with abradant substances.

Sodium hydroxide (caustic soda). Sodium sulphate (Glauber's salt).

Springs, metal, other than undercarriage springs.

Toilet paper in sheets or rolls.

FIRSTLY, all that area adjoining the City of Invercargill and situated partly in the County of Southland and partly in the Borough of South Invercargill, bounded by a line commencing at the extreme south-eastern point of the present boundary of the City of Invercargill and proceeding eastward along the middle line of McQuarry Street to a point three chains east of Brown Street; thence north parallel to Brown Street; thence east parallel to Tramway Road and three chains south of it; thence north and north-west parallel to Rockdale Road and Cemetery Road and three chains therefrom as far as the south boundary of the cemetery; thence south-west to the middle line of Cemetery Road; thence generally north-west along the middle line of Cemetery Road and the middle line of Racecourse Road to the present boundary of the City of Invercargill at Findlay Road; thence south-west generally along the said boundary to the said point of commencement.

Secondly, all that area adjoining the City of Invercargill and situated in the County of Southland, bounded by a line commencing at the extreme north-east point of the present boundary of the City of Invercargill near Layard Street, and proceeding parallel to Racecourse Road and its proposed extension and three chains east therefrom to and across Bainfield Road; thence west parallel to Bainfield Road and three chains north thereof to a point three chains west of Elles Road; thence south parallel to Elles Road and three chains west thereof to the northern boundary of the Waihopai Scenic Reserve; thence west and south by the boundaries of the Scenic Reserve Section 11, L.T.P. 2485 and Part Section 11, Block IV, Invercargill Hundred, to the present boundary of the City of Invercargill near Grey Street; thence east generally along the said boundary to the point of commencement.
