This Public Bill originated in the Legislative Council, and, having this day passed as now printed, is transmitted to the House of Representatives for its concurrence.

A BILL INTITULED

An Act to amend "The Inebriates Institutions Act, 1898." BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows:

1. The Short Title of this Act is "The Inebriates Institutions Short Title. Amendment Act, 1903"; and it shall form part of and be read together with "The Inebriates Institutions Act, 1898" (hereinafter referred to as "the principal Act").

2. The Governor may from time to time, by Order in Council, Institutions for 10 direct that any institution, whether established before or after the curable or non-curable inebriates. passing of this Act, shall be for the reception of curable inebriates

3. Notwithstanding anything in the principal Act, no order shall Inebriates to be 15 be made by any Judge or Magistrate for the committal of any person committed to curable institution to an institution for the reception of curable inebriates, or for his only on medical reception therein, except upon the certificate of two duly qualified certificate. medical practitioners that, in their opinion, there is a reasonable prospect of the permanent recovery of the inebriate.

4. (1.) The Colonial Secretary may, by writing under his hand, Removal of 20 order the removal of any inebriate from any institution to any other inebriates.

- (2.) Such order shall be sufficient authority for the removal of such inebriate, and also for his reception into the institution to 25 which he is ordered to be removed.
 - 5. Any regulations made under the principal Act may provide Regulations. for the separate treatment of curable and non-curable inebriates, and may apply only to any specified institution or generally, as the Governor in Council thinks fit.
