AN ACT to amend the Local Elections and Polls Act, 1925. Title. BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows :---

1. This Act may be cited as the Local Elections and Polls Amend- Short Title. ment Act, 1931, and shall be read together with and deemed part of the Local Elections and Polls Act, 1925 (hereinafter referred to as the principal Act).

When a special order is or has been made by any local authority Local authority may adopting the provisions of Part II of the principal Act the local adopt alternative authority may in the special order, or at any time subsequently by resolution, declare that the alternative provisions set out in the Schedule hereto shall apply in lieu of the corresponding provisions

SCHEDULE.

ALTERNATIVE PROVISIONS TO SECTIONS 76 AND 78 OF LOCAL ELECTIONS AND POLLS ACT, 1925.

76. The voter shall vote by placing the figure 1 opposite the name of the candidate for whom he votes. He may in addition place the figure 2 opposite the name of the candidate who is his second choice, and the figure 3 opposite the name of the candidate who is his third choice. He may also indicate the order of his preference for as many of the other candidates (if any) as he pleases by placing in the squares respectively opposite their names other figures next in numerical order after those already used by him.

78. A voting-paper is informal on which-

- (a) The figure 1 standing alone, indicating a first preference, is not placed; or
- (b) The figure 1 standing alone, indicating a first preference, is placed opposite the name of more than one candidate; or

- (c) The figure 1 standing alone, indicating a first preference, and some other figure are placed opposite the name of the same candidate ; or
- (d) It cannot be determined for which candidate the first preference of the voter is recorded; or
- (e) Any mark is placed by the voter by which he may afterwards be identified.

ALTERNATIVE PROVISIONS TO THOSE CONTAINED IN THE THIRD AND FOURTH SCHEDULES TO LOCAL ELECTIONS AND POLLS ACT, 1925.

Directions to be printed on voting-paper (in lieu of those in Third Schedule).

CROSSES SHOULD NOT BE USED.

Vote by placing the figure 1 opposite the name of the candidate for whom you vote.

You may also place the figure 2 opposite the name of the candidate who is your second choice, and the figure 3 opposite the name of the candidate who is your third choice, and so on as far as you may choose.

FOURTH SCHEDULE.

METHOD OF COUNTING VOTES.

Definitions.

- In this Schedule, unless the contrary intention appears,-
 - The expression "continuing candidate " means any candidate not elected or not excluded from the poll at any given time:
 - The expression "first preference" means the figure 1 standing alone opposite the name of a candidate; "second preference" means the figure 2 standing alone opposite the name of a candidate in succession to the figure 1; "third preference" means the figure 3 standing alone opposite the name of a candidate in succession to the figures 1 and 2; and so on:
 - The expression "next available preference" means a second or subsequent preference recorded in consecutive numerical order for a continuing candidate, the preferences next in order on the voting-paper for candidates already elected or excluded from the poll being ignored :
 - The expression "transferable paper" means a voting-paper on which, following a first preference, a second or subsequent preference is recorded in consecutive numerical order for a continuing candidate:

The expression "non-transferable paper" means a voting-paper on which no second or subsequent preference is recorded for a continuing candidate :

Provided that a paper shall be deemed to have become a non-transferable paper whenever—

(a) The names of two or more candidates (whether continuing or not) are marked with the same number, and are next in order of preference; or

(b) The name of the candidate next in order of preference (whether continuing or not) is marked—

- (i) By a number not following consecutively after some other number on the voting-paper; or
- (ii) By two or more numbers; or

(c) For any other reason it cannot be determined for which of the continuing candidates the next available preference of the voter is recorded :

The expression "original vote" in regard to any candidate means a vote derived from a voting-paper on which a first preference is recorded for that candidate :

The expression "transferred vote" in regard to any candidate means a vote derived from a voting-paper on which a second or subsequent preference is recorded for that candidate :

The expression "surplus" means the number of votes by which the total number of the votes, original and transferred, credited to any candidate, exceeds the quota:

The expression "count" means-

(a) All the operations involved in the counting of the first preferences recorded for candidates; or

(b) All the operations involved in the transfer of the surplus of an elected candidate; or

(c) All the operations involved in the transfer of the votes of an excluded candidate or of two or more candidates excluded together.

First Choice.

1. The number of first choices recorded for each candidate shall be counted, and all First choice of informal voting-papers shall be rejected.

Sorting Papers.

2. After the voting-papers have been mixed the Returning Officer shall examine Voting-papers the voting-papers and shall sort them into parcels according to the first preferences to be sorted. recorded for each candidate, rejecting any that are invalid.

Counting Papers.

3. The Returning Officer shall then count the number of papers in each parcel, and Voting-papers to shall credit each candidate with a number of votes equal to the number of valid papers be counted and on which a first preference has been recorded for such candidate, and he shall ascertain credited. the total number of valid papers.

The Quota.

4. The Returning Officer shall then divide the total number of valid papers by a Ascertaining quota. number exceeding by one the number of vacancies to be filled. The result increased by one (any fractional remainder being disregarded) shall be the number of votes sufficient to secure the election of a candidate. This number is herein called the "quota."

Candidate with Quota elected.

5. If at the end of any count the number of votes credited to a candidate is equal When candidate to or greater than the quota, that candidate shall thereupon be elected. elected.

Transfer of Surplus.

6. (1) If at the end of any count the number of votes credited to a candidate is Surplus to be greater than the quota the surplus shall be transferred, as in this regulation provided, transferred. to the continuing candidates for whom the next available preferences have been recorded on the voting-papers in the parcel or sub-parcel last received by the elected candidate.

(2) (a) If more than one candidate has a surplus, the largest surplus shall be first Priority of surplus. dealt with.

(b) If two or more candidates have each an equal surplus, the surplus of the candidate with the greatest number of votes at the first count at which the candidates in question have an unequal number of votes shall be first dealt with. When the numbers of votes credited to such candidates are equal at all counts, the Returning Officer shall determine which surplus he will first deal with.

(3) The Returning Officer need not transfer a surplus when that surplus, together Transfer of surplus with any other surplus not transferred, is less than the difference-

- (a) Between the votes of the candidate lowest on the poll and the votes of the next highest candidate; or
- (b) Between the total of the votes of the two or more candidates lowest on the poll and the votes of the next highest candidate, provided that the exclusion from the poll of the aforesaid two or more candidates lowest on the poll shall not reduce the number of continuing candidates below the number of vacancies remaining to be filled.

(4) (a) If the votes credited to an elected candidate consist of original votes only, Surplus from the Returning Officer shall examine all the papers contained in the parcel of the elected original votes. candidate whose surplus is to be transferred.

(b) If the votes credited to an elected candidate consist of original and transferred Surplus from votes, or of transferred votes only, the Returning Officer shall examine the papers transferred votes. contained in the sub-parcel last received by the elected candidate whose surplus is to be transferred.

(c) In either case the Returning Officer shall sort the transferable papers into sub- Papers sorted to parcels according to the next available preferences recorded thereon, shall make a separate next available sub-parcel of the non-transferable papers, and shall ascertain the number of papers in each sub-parcel of transferable papers and in the sub-parcel of non-transferable papers.

(5) If the total number of papers in the sub-parcels of transferable papers is equal If transferable to or less than the surplus, the Returning Officer shall transfer the whole of each subparcel of transferable papers to the continuing candidate indicated thereon as the voters' next available preference, and shall set aside as a separate sub-parcel so many of the non-transferable papers as are not required for the quota of the elected candidate. The particular papers set aside shall be those last filed in the sub-parcel of non-transferable papers.

(6) (a) If the total number of transferable papers is greater than the surplus the Returning Officer shall transfer from each sub-parcel of transferable papers to the continuing candidate indicated thereon as the voters' next available preference the number of papers which bears the same proportion to the number of papers in the sub-parcel as the surplus bears to the total number of transferable papers.

(b) The number of papers to be transferred from each sub-parcel shall be ascertained by multiplying the number of papers in the sub-parcel by the surplus and dividing the result by the total number of transferable papers. A note shall be made of the fractional part, if any, of each number so ascertained.

(c) If, owing to the existence of such fractional parts, the number of papers to be transferred is less than the surplus, so many of these fractional parts taken in the order of their magnitude, beginning with the largest, as are necessary to make the total number of papers to be transferred equal to the surplus shall be reckoned as of the value of unity, and the remaining fractional parts shall be ignored.

(d) If two or more fractional parts are of equal magnitude, that fractional part shall be deemed to be the largest which arises from the largest sub-parcel, and if the subparcels in question are equal in size, the fractional part credited to the candidate with the greatest number of votes at the first count at which the candidates in question have an unequal number of votes shall be deemed to be the largest. When the numbers of votes credited to such candidates are equal at all counts the Returning Officer shall determine which fractional part shall be deemed to be the largest.

(e) The particular papers transferred from each sub-parcel shall be those last filed in the sub-parcel, and each paper so transferred shall be marked in such a manner as to indicate the count at which the transfer took place.

Exclusion of Candidates.

7. (1) If at the end of any count no candidate has a surplus, or if any existing surplus need not be and is not transferred, and one or more vacancies remain to be filled—

(a) The Returning Officer shall exclude from the poll the candidate lowest on the poll; but

(b) If the total of the votes of the two or more candidates lowest on the poll together with any surplus not transferred is less than the number of votes credited to the next highest candidate, the Returning Officer may at the same count exclude the aforesaid two or more candidates lowest on the poll, provided that the exclusion of these candidates shall not reduce the number of continuing candidates below the number of vacancies remaining to be filled.

(2) If, when a candidate has to be excluded, two or more candidates have each the same number of votes and are lowest on the poll, the candidate with the lowest number of votes at the first count at which the candidates in question have an unequal number of votes shall be excluded, and, when the numbers of votes credited to these candidates are equal at all counts, the Returning Officer shall determine which shall be excluded.

(3) Upon the exclusion of any candidate, the Returning Officer, save as hereinafter provided, shall examine all the papers credited to that candidate; shall sort the transferable papers into sub-parcels according to the next available preferences recorded thereon for continuing candidates; shall transfer each sub-parcel to the candidate for whom that preference is recorded; and shall set aside as a separate sub-parcel the non-transferable papers.

Last Vacancies.

8. (1) If at the end of any count the number of elected candidates is equal to the number of vacancies to be filled, no further transfer of votes shall be made.

(2) If on the exclusion of a candidate or candidates the number of the then continuing candidates is equal to the number of vacancies unfilled, the continuing candidates shall thereupon be elected, and no further transfer of votes shall be made.

Priority of Election.

9. The order of priority of election of elected members shall be the order in which they are severally elected. If at the end of any count two or more candidates are elected, the order of priority shall be the order of magnitude of the numbers of votes credited to such candidates, beginning with the greatest. 10. (1) Whenever any transfer is made each sub-parcel of papers transferred shall be placed on the top of the parcel, if any, of papers of the candidate to whom the transfer is made, and that candidate shall be credited with a number of votes equal to the number of papers transferred to him.

(2) Non-transferable papers (except such as in the transfer of a surplus may be required for the quota of the elected candidate) shall be set aside as a separate sub-parcel, together with any parcel of non-transferable papers already set aside.

(3) On the transfer of the surplus of an elected candidate, all papers not transferred to continuing candidates and not set aside as provided in the preceding paragraph shall be placed together in one parcel as the quota of the elected candidate, and the parcel shall be marked with the name of the elected candidate.

Partial Re-counts.

11. Any serutineer may, at the end of any count, request the Returning Officer to re-examine and re-count all or any of the papers dealt with during that count, and the Returning Officer shall forthwith re-examine and re-count accordingly the papers indicated without making any alteration in the arrangement of the papers in the various parcels, save where such alteration may be necessary in consequence of any error discovered in the re-count. The Returning Officer may also at his discretion re-count papers either once or more often in any case in which he is not satisfied as to the accuracy of any previous counting of the votes : Provided that nothing herein shall make it obligatory on the Returning Officer to recount the same papers more than once.
